1)	Welcome and Introductions	Introductions for new members or those sitting in took place.	
2)	Review and Approval of Previous Minutes of May 27, 2021	Minutes were approved as circulated.	
3)	Action Items	 a) Jean-Laurent to have an online survey created for resources available to assist individuals attending court virtually, compile a list with details of accessibility, and send to the committee and defence counsel. The individual compiling results from the survey has been away on leave. The survey will be re-sent to committee members to provide updated information. Results to be brought back to next meeting. 	
4)	Closure of Youth Justice Facilities – Can This Committee Provide Assistance?	 The numbers are really high. Ottawa has been at capacity at the open site for a number of weeks. As a result a number of youth offenders have had to be transported to Trenton. The effects of COVID and closures are starting to be seen. The ministry does not allow in person visits for families. The transition back into the community has been a challenge with barriers. Getting youth back home has also been a challenge. Action: The transition from custody sub-committee to discuss issues and look at solutions. Lisa St. Pierre volunteered to participate in this committee. This topic to rise in priority level. Identify in a concrete way what the problems are and identify solutions that may be tenable from a local perspective with a view to seeing what can be done. Action: Add as a standing item to the agenda. 	
5)	Youth Mental Health Court Update	Justice Perkins-McVey is in the process of scheduling a meeting. The youth mental health court has seen some changes with the crown attorney away on leave. Kyle Grant will be taking on the responsibility. They have not been running in a structured way during the pandemic. Justice Perkins-McVey is advocating on a regular basis for it to return to a structure way. Numbers have been down because cases are being dealt with in other ways. There are currently 5 active clients in the youth mental health court.	
6)	2021 Regional Work Plan – Committee Reports	 a) Orientation Package The committee met two weeks ago. A new manager in Learning and Development at CMHA will be developing a new web-based version of the orientation package and Lisa St. Pierre will bring it back for review.

	 A meeting was held a few weeks ago. The hope is to have someone from the ROH on the committee to help with the education piece. The focus will be on training for people on CBT basics. Sarah Telford will join the committee. An important component to education is having speakers/presentations to provide information/education on programs in the community. It may be helpful to have a roster to schedule these informative sessions. Some ideas were: 1Call1Click program hosted by CHEO serving the Champlain region for youth – young adults up to age 21 (for some services) – potential presentation for November (Colleen McPhee). The opioid crisis - how COVID has exacerbated it and if there are barriers with the closure of certain facilities (Colleen McPhee/Gord Hudson/Holly Watson) to be presented in January. Wendy Muckle with Inner City Health was suggested to be included. Action: Presentation to be confirmed at the meeting in November. 		
	 c) Animal Care While in Treatment I. Jan and Justice Perkins-McVey to provide update on SafePet partnership SafePet Ottawa, now called FAM Network, has received their funding to be able to support clients who need help placing their pets while in treatment. <u>Action</u>: Jan to put together a one-pager from FAM Network and send out to everyone. This is also an idea for a short presentation.

	 The Release from Custody is now the Transition from Custody committee. Surveys will be going out in the next month or so to gather information on how each area in Ontario is doing and where there could be improvements. Information will be brought back from that and will be looked at in the November meeting. Amber will join this committee. 		
	e) Innovative Ways to Support Individuals with More Barriers During the Pandemic		
	 There is a framework at JHS to assist those attending court with a chromebook at their offices. Renfrew County has challenges with internet access and staffing to assist clients. An iPad and loaner phones were purchased for this purpose. CMHA has been working to assist clients. Shelters, community centres, and agencies have been supportive assisting clients attend court. It hasn't 		
	been as much of a challenge as it was in the beginning.		
	f) Renfrew County		
	 Mental Health Court is a work in progress. The barrier has been getting a crown attorney in place permanently. The process and procedure is up for debate but MHC is in place. 		
	g) SD&G/Prescott-Russell/Akwesasne		
	 This fall, the Prescott-Russell Hoarding Response Coalition is launching a new prevention and education campaign aimed at preventing and reducing the negative impacts of hoarding in the households of various municipalities in Prescott and Russell. 		
	10 steps to a safer, healthier and more comfortable home		
	A bilingual fact sheet called "10 Steps to a Safer, Healthier, More Comfortable Home" will be distributed to homes at the same time as the various fire departments conduct their regular fire prevention campaigns in their communities. With the help of a checklist, this sheet simply explains the various ways to prevent the risks of fire, unsanitary conditions and other dangers often associated with hoarding. 	About the Coalition		
	The Prescott-Russell Hoarding Response Coalition has been in existence since 2012. Members of this coalition come from various sectors such as mental health, municipal and social services. They work together to prevent negative consequences associated with hoarding such as fires and evictions. A collaborative approach that considers the mental health challenges of individuals has proven to be very effective in helping to maintain the housing and well-being of people affected by hoarding, their families and sometimes even their neighbors. Training, meetings, mutual aid and partnerships between members are part of the Collaborative Agreement of the Prescott-Russell Hoarding Response Coalition.

7) Provincial Highlights	Provincial highlights were circulated to the committee.		
8) Roundtable	 CMHA (Lisa St. Pierre) The proposal submitted to the University of Ottawa to evaluate the court system navigator functions was accepted. Some partners may be contacted in relation to this. A pilot project is being done with the Minister of the Solicitor General for a peer support program. A court outreach worker for those who are on probation was decided upon. A candidate for the peer support worker position has not yet been found. Creating a training program to train someone to be a peer is being looked at, specifically someone with lived experience, experience with mental health and justice, and bilingual. 		
	 Justice (Justice Perkins-McVey) Specialized courts are not running except for Mental Health Court. A full day is being looked at due to the need but not there yet. Drug treatment court continues to run with a dedicated zoom line. Early Intervention Drug Treatment Court is for persons looking at a much shorter jail sentence but are often very high needs with significant addictions.

The trade centre is being pushed to youth to try to build skills and therefore be more employable. Working with the foundation is being done to get some training courses done and some certifications completed.
