The date was set for March 8, 2018 from 12:30 pm to 2:30 pm, in Orillia. Mary Martin of CNCC replaced Judy.</li> <li>● HSJCC “lunch and learn” event to be announced for all local and regional members, possibly in June, as part of a Network Member Engagement Plan activity – yet to be determined</li> </ul>	
<p><b>Round Table Updates</b></p>	<ul style="list-style-type: none"> <li>● <b>Blair – Court Diversion CMHA:</b> Increase in client referrals.</li> <li>● <b>Terri – Probation &amp; Parole:</b> New Assistant Manager – Kim Richards. She was a previous trainer at OCS.</li> </ul>	



	<ul style="list-style-type: none"> <li>● <b>Rhonda – 211:</b> Brief update on common point - 211 is the “Common Point” increase in calls over 6 months. Follow-up is conducted with callers making sure they have received services or if additional resources are required.</li> <li>● <b>MHRU:</b> extended funding for 18 months. Upcoming presentation to LHIN in March re unit successes. Recent client success with Salvation Army funding partner.</li> <li>● <b>Alice Afram (CGMH Crisis):</b> New administrative co-lead, Katherine Corry. New VP Patient Experience, Karen Fleming. Crisis currently hiring for casual workers. Monthly education and support groups being led by crisis worker Diane Colvin.(see attachment)</li> <li>● <b>Monica Holmes (EFRY):</b> Replacing Avery Crampton’s role in Collingwood. New Youth Trustee Program. Youth 16, 17 are eligible. (see attachment)</li> <li>● <b>Wayne Monague (Enahtig):</b> New Release from Custody worker</li> <li>● <b>Fayssoux Bombardier (SGBCHC):</b> Staffing changes; currently .5 social worker and there is a waitlist. Upcoming “after baby group” begins Jan 30 every Tuesday morning. Open to the community.</li> <li>● <b>Julian Millman (CSP):</b> They are receiving an increase in referrals from court diversion. 21 new members in 2017 vs 10 in 2016.</li> <li>● <b>Darcy Plummer (OW):</b> Quarterly stats are down as employment rate has increased.</li> <li>● <b>Jean-Marc Pelot (CMHA):</b> Advised that Director of Support Services, Jim Harris (JM’s direct supervisor) was accepted a new position of Director of Operations with CMHA-Ontario</li> </ul>
