Presentation – Lara McLachian on the Pilot INKH: Inmate Community Health Project

- The PowerPoint slides will be distributed with the meeting minutes.
- INKH is a 12-month pilot project designed by four core agencies: John Howard Society of Toronto, Mississauga Halton CCAC, LAMP CHC and

Toronto South Detention Centre (TSDC). Led by the South Etobicoke Health Link.

- Approaches incarceration as an opportunity to improve health outcomes for the most medically and socially complex individuals at the TSDC, specifically when they are released in the community.
- Ensures that: Support is available in detention to develop a care plan and coordinate care
- Attachment to primary care in the community to support when inmate is released
- A circle of care on helping the patient meet self-defined goals
- Aims to involve approximately 80 inmates over the course of the project
- Overview: The INKH team works with the inmates to create a plan, engages external providers and works with inmates to ensure they receives support in the community
- Rationale: MOHLTC Health Link's initiative is focused on improving quality and efficiency of healthcare for the highest users of the healthcare system
- Challenge unexpected release at TSDC
- Identifying clients at TSDC those living in the Medical Housing, Special Needs and Mental Health of TSDC with a combination of: 4 + chronic or high cost condition, chronic medication, MH and addiction challenges
- PLUS social complexity or barriers to the social determinants of health
- And unable to navigate and coordinate their health care in the community
- INKH Process: Referral, Care Plan, Circle of Care, Ongoing Planning, Community Supports
- Frontline nurse identifies the inmates at TSDC and John Howard Society of Toronto peer workers work in tandem.
- Evaluation part of the project
- Project outline will be circulated with the minutes.

Themes discussed: Looking at using telemedicine. Health Links has not looked at justice first model. However, they are moving towards a patient first model instead of inmate first model.

Bail Program has hired staff to work with complex clients; to ensure that they will follow up with appointments. Supervision will be enhanced. Will meet clients where they are and accompany them to court. MHC Crystal Sinclair is on a leave.
- Jennifer Altosaar informed the committee that the Toronto Network of Specialized Care and Development Services Toronto is planning training in February for three consecutive Thursdays. Will send information to Domenica Dileo for circulation.
- Lindsay Jennings the PASAN will be at Moss Park on February 3rd from1-3:00 p.m. distributing harm reduction kits. Will send flyer to Domenica Dileo for circulation.
- Nikki Nosworthy reported that the Service Resolution Project will be hiring a Justice Coordinator to provide expertise for one day a week. Job posting and host agency criteria will be circulated.
- Katie Almond and Sarah Easterbrook provided an update on Corrections.
 They are working at the cooperate level developing the staff and client Mental Health Strategy.
