## Review of January 4, 2017 Minutes

The minutes of January 4, 2018 were approved.

#### **Review Action Items:**

Domenica Dileo to ensure that the Bail and Remand in Ontario Report and Trauma tool kit link is circulated.

**Presentation** – Tanya Connors and Kiren Sandhu from CAMH Forensic Early Intervention Service (FEIS)

• PowerPoint slide decks will be circulated with meeting minutes

Overview of the FEIS at TSDC and Vanier Centre for Women, STAIR Model, Brief Jail Mental Health Screen, and future directions were discussed.

- 20-25 % of people in jail have a serious mental illness, 80-100% have substance use issues. 60-70% have a CAMH record
- Access to Jail/Prison Mental Health Services many who screen positive will be assessed by FEIS and referred back to TSDC for further MH services
- One benefit of having the FEIS team complete the JSAT, is that team has the time and resources to get collateral information that helps with case management.
- FEIS will continue to work with most acutely unwell who have matters before the court.
- TSDC: Interdisciplinary team psychiatrists, psychologists, nurses, SW

STAIR MODEL- **S**creening, **T**riage, **A**ssessment, Intervention, **R**e-integration. Discussed the STAIR Care Pathway

- FEIS Enhance access to acute forensic services. It compliments MH services provided by MCSCS
- FEIS can see anyone from TSDC or Vanier who have matters before the court
- Discussion ensued: Feedback on screener word 'sinful' can put barriers for clients

Tanya Connors and Kiren Sandhu were thanked for their informative and interactive presentation.

Following the presentation, the role of the DT-HSJCC to advocate was addressed. Themes discussed: need for housing alternatives, need for substance use diversion, coordinate access to hospital beds due to lack of hospital beds. Dementia clients, where do they go? How are safety concerns addressed?

Scott Large provided an update on the TSDC: 300 Correctional Officers and 30 Sergeants were hired. Lock downs and segregation usage going down. In six weeks they are opening an Indigenous Healing Centre. 60% of clients stay less than 2 weeks. TSDC is increasing social activities.

# 2018-2019 Workplan:

Reviewed the 2018-2019 workplan, which was circulated prior to the meeting. Discussion ensued- to continue with the regular five meetings and three Lunch N' Learns. Continue with the TTC and food voucher support for OCH and College Park. The goals and objectives remain the same as previous year.  Domenica Dileo reported that the budget goal of the T-HSJC is to have a balanced budget. After reviewing the Locals budget requests, the committee had to limit the amount of TTC tokens and food vouchers for all Locals with the understanding that surplus can be used for TTC tokens and food vouchers purchases. The T-HSJCC will review outstanding Locals budget requests in the Fall.

The DT-HSJCC 2018-2019 workplan budget approved is:

The DT-HSHCC committee unanimously approved the 2018-2019 workplan and budget. Proposed meeting dates are: September 13, November 1, January 10, March 7 and May 2<sup>nd</sup>.

Had a very successful Lunch N' Learn evening panel titled "The Cannabis Act: Youth, Mental Health and Public Safety" with Mary Birdsell, Justice for Children and Youth; The Honourable Justice Marion Cohen; Carol Shirtliff-Hinds, Public Prosecution Service of Canada (Agent); Dr. Sharon Cirone at City Hall.

This session was Law Society of Ontario Accredited. Had suggestion how to make it accessible for people who can't donate for food to attend. For example, pay what you can. The panel adhoc planning committee was thanked for their work - specifically Esther Daniel, Judiciary.
