- What is SS&A Implementation of a new staged screening and assessment process in all publicly- funded (Ministry of Health/Local Health Integration Network) addiction programs in Ontario.

Themes discussed: Is there a plan to use the findings for funding to advocate for increased services of programs? At this point no training for correctional staff regarding SS&A or OPOC-MHA. There is a cognitive impairment screener The substance use addiction section has questions for gambling and eating disorder. Can the data be used for research? Don't know.

Concerns that tools are clinically focused and not from a recovery perspective

In this role, she will provide justice expertise (i.e., justice information, justice system navigation, and justice education/capacity development) at existing tables (Toronto Specialized Network of Care, FOCUS, Health Links) by working collaboratively with table members to develop more appropriate service options for clients with current or emerging justice needs. She will also work to identify service and policy issues, identify solutions to systemic problems, and make recommendations for further integration of justice supports into the existing system of situation and service resolution tables.
