### Welcome and Introductions

- Everyone introduced themselves
- The agenda was amended to start with the presentation

### **Presentation**

Katie Almond introduced Howard Sapers. He provided the context for his two reports.

 He was appointed as the Ontario Independent advisor on Corrections Reform in January 2017. His first report, Segregation in Ontario, was released May 2017 followed by his second report October 2017, Corrections in Ontario: Directions for Reform. This report provides a targeted examination of select

- correctional practices in Ontario. The report includes 62 recommendations. Mr. Sapers would like advice from the committee on how to move forward.
- Links to the reports were circulated.
- The Government of Ontario asked him to look at segregation. How do you make it transparent and accountable? Segregation is a symptom.
- **Key Finding:** Segregation is frequently used as the default tool to manage individuals with mental health needs; the current infrastructure contributes to the overuse of segregation; Ministry is behind in information collection, management and sharing, lack of project coordination, communication and consultation with key partners; there is no clear policy for dealing with client complaints; the corrections Act of Ontario should contain a statement of purpose for visits; remand clients must be treated in accordance with their legal status- innocent
- **Key Recommendations:** New legal and public framework; amend policy to update the definition of segregation in line with international standards. Prohibit segregation for medical observation, pregnant women, chronically self-harming, suicidal; limit segregation to no more than 60 days, update policy, implement standardized and ongoing MH screening for segregated clients; evaluate the provision of health care in correctional facilities; Ministry policies and statistics be publicly available; enhancing respect for Human Rights with Corrections
- Themes discussed: Correction is a Human Rights enterprise, be evidence based, principle driven and be accountable. Need to look through the lenses of Human Rights; safety concerns for staff were addressed, when you make the institutional healthy for the clients, the staff will be healthy. The government responded quickly to the reports. New legislation is in the making and new bills. Suggestion about the provincial grievance process Ombudsman, Human Rights and Auditor General provide alternatives. How about an Office Inspector General from MAG? This can strengthen the internal grievance process. Concern that the Ombudsman does not deal with the administration of health.
