### Overview:

- Research on Traumatic Brain Injury, MH and Addictions in vulnerable populations. It incorporates Sex and Gender into the work and research
- How can you be involved?
- Key components of the research is: Cross-sectoral engagement with knowledge users, caregivers of persons with lived experience and service providers through research participation

Themes discussed: Notion of educating people from an informed traumatic brain injury as universal approach can be helpful. Can we weave together ABI and concurrent challenges? Can we integrate ABI research in the context of housing, safe beds, and transitional housing concerns? Can we look at the research through the lenses of Dementia and Alzheimer?

- How would you like to be involved? It was suggested having focus groups and individual interviews are ways members can participate
- It was agreed that the research team can provide periodic updates at the DT-HSJCC meetings.
- If you have clients with lived experience interested in participating in the study please refer them to the research team. They are looking for persons with lived experience who can join study's Program Advisory Committee (PAC) There are incentives for participation. PAC invitation letter will be sent for circulation.

## **Toronto HSJCC Service Resolution Project Update**

Susan Davis reported on the T-HSJCC meeting that took place on October 31, 2018.

Main agenda item was the Service Resolution Project. The T-HSJCC reviewed two Service Resolution (SR) Project options for the HSJCC to support and next steps.

SR project: To identify gaps in access and support for individuals with complex needs in the justice system; Develop recommendations for integration of justice supports into the existing social and justice systems

Two options were presented. Pros and cons were discussed for Option 1 and 2. Option 1 is to continue supporting the Justice Coordinator role. Option 2 is to explore a Local HSJCC to transform into a SR table. There was concern that Option 2 requires more resources. The committee unanimously agreed to continue with Option 1 but continue to explore Option 2. The T-HSJCC to pursue and secure additional funding to support either option.

## **Agency/Organization Updates**

Michelle Campese, Moss Park Neighbourhood Officer provided information on the Dundas and Sherbourne Neighbourhood Improvement Initiative Safety Survey. Survey will be circulated to committee members.

Amber Kellen reported that the John Howard Society of Toronto (JHS-T) received standing in the inquest into the death of Bradley. The Reintegration Centre (RC) rental agreement will not be renewed as of January 31. They are looking at mobile options. Any suggestions please contact Amber.

Lindsay Jennings reported that PASAN has a harm reduction program at Moss Park.

Susan Davis reported that the Gerstein Centre was approached by the City of Toronto to increase mobile services in the downtown area. They are working with outreach workers from the WORKS to support people. Also, operating 24 hours and working with drop-in centres, St. Stephens and peer navigation from Sound Times; Regent Park, Sherbourne and Street Health. At the end of the six months project there will be an evaluation. Elaine Amsterdam is the lead on this project.

Scott Large reported on Toronto South Detention Centre(TSDC), They are doing Human Rights Tribunal at TSDC. Bail video has started at Old City Hall.
