### **Review of May 2, 2019 Minutes**

### **Review Action Items:**

Presentation: Community Justice Centres with Delia Greco and Scott McKean

- PowerPoint slide decks will be circulated
- Background on the Justice Centres was provided

- "Long-term and sustainable reduction of guns, gangs and violence requires a cross-sectoral approach that works collectively on enforcement, intervention and prevention, to achieve shared goals"
- There will be four centres across the province in Kenora, London, Toronto-Downtown East (Adults aged 18+) and Toronto- Northwest (Youth focus). The Justice Centres are funded through the Guns and Gangs Strategy.
- **Themes discussed:** Move justice out of the traditional courtroom and into a community setting with front-end supports, prevention services and community re-integration supports. Alternative way to address charges, helping victims and accuser. Community & Safety Wellbeing imbedded in the justice centers. Why post charges? Criminal code has been amended providing broader police power at the station. Opportunity for cultural shift of the police to use discretion. Feedback was provided regarding the stigma of using the term offender instead of client. Highlight development disability population.

# Medical Files Transfer Fee Survey:

Domenica reported that 17 members completed the survey from four locals and one regional table.

The following question was asked: Have your patients/clients experienced payment to transfer their medical files in order to access medical care?

From the respondents 30- 70 clients in the last 12 months had to pay a fee to see a new family doctor for their transfer.

Survey results will be brought to the regional table for discussion.

- There was one question about starting the meeting at a later time. Discussion ensued. Suggestion were made: is there teleconference available? It was agreed to continue with the 8:30 a.m. meeting time.

## Lunch and Learns

- Domenica reported that the next Lunch and Learn will be on Domestic Sex Trafficking of Youth.
- It was agreed for the second Lunch N" Learn to be on the topic of Crystal Meth. Audience- front line staff. To address strategies about working with clients who are using methamphetami.

# Agency/Organization Updates

- Amber Kellen reported that John Howard Society of Toronto has a new Lakeshore location. This includes six units of supportive housing, plus 30 housing subsidies and three bachelor apartments. More family members are using their services. A trailer of 17 feet was purchased and its located in the parking lot of the Toronto South Detention Centre. They are seeing 100 clients per month, including more women. New location is immensely increasing the clients they are serving per month. John Howard Society of Toronto is now unionized.
- Flora Matheson reported on the Life Skills groups at Good Shepherd, providing gambling treatment for people experiencing poverty and homelessness.
- ICare Kit was presented and demonstrated by Alex Monkrob. The kit was developed from their own experience. Alex was thanked for sharing them experience.
