### **Review Action Items:**

All actions items were reviewed and completed.

**Presentation:** Lin Sallay and Radha Nagar on Cota's new Assertive Housing First Team.

- Based on John Howard Society research which identified the importance of having a consistence care team and increase supportive housing resources.

- Housing and Support Services will be together for Mental Health and Justice population.
- There will be rent supplements for 100 permanent housing units.
- Eligibility criteria: MH and correctional centres, age- 18 years plus,
- Referral through the access point
- Active or chronic homelessness
- Intend to live in Toronto for one year or longer
- MH court support: 3 or more incidents of court appearances
- Release from custody 1 or more incidents
- Outcomes are determined by the funder
- Team has addiction case managers

**Themes discussed:** What is the housing model? Scattered units? All options are on the table. What does assertive mean? No court order to take meds or a housing model and psychiatry treatment? Drug treatment court involvement? Time of service 9-5 or when? Evaluation plan? How do you define chronic – folks who do not need long term care. Indicators will come from OCAN. Will be looking at process evaluation. Cognitive imperative will include ABI. Does it include TBI? What about sex offenders and arson charges? Gap in youth who are transitioning with a developmental different age? Suggestion to look at drop-ins as well as specific days at court instead of no. of appearances. Suggestion to partner with DSO.

When the formal Boucher and/or pamphlet is completed it will be circulated to the HSICC members
