#### **Lunch and Learns**

Domenica Dileo reported on the Lunch N' Learn session titled: Understanding the Impacts of Trauma with Kathryn Mettler, MSW which took place on January 30<sup>th</sup>, 2019 at OCH Room 14. Total participants were 24 and 18 (86%) completed the evaluation. The session was rated 100% as above average to excellent. Learning objectives were greater understanding of the impacts of trauma and trauma responses and improved capacity to respond to persons with trauma histories. Suggested topics for Lunch and Learns were: Autism and Personality Disorder.
