# **Agencies Updates**

- Sistering is partnering with Margaret Fraser House. A case manager from Margaret Fraser goes on site to Sistering.
- The Gerstein Centre addiction program has received core funding. There are six beds at Ossington Detox to help with ER demands. To access the service, call the Gerstein Crisis line 416-929-5200.
- The Schizophrenia Society of Ontario is going through transition. Julie Pagliaro is moving to policy and advocacy, which will provide limited support to the family program.
- Sandi Bricker reported that the Toronto Network of Specialized Care (TNSC) is beginning a process to bring together an "Inter-ministerial Service Resolution for Complex Clients" with a Dual Diagnosis (Developmental Disability, Mental Health Needs and/or Challenging Behaviour). Historically, a number of the people who need this level of collaboration have fallen through the cracks. Since they use multiple services funded by multiple ministries, there is a need for an Inter-ministerial response. There will be an initial meeting at the end of January where Justice, Health and the Ministry of Community and Social Services will be involved.

## Updates from the T-HSJCC and Provincial HSJCC

- The due date for the Police ER Protocol Project is January 15, 2013. The following concerns were identified: How is this project different from other projects on the ER issues? How do you integrate the various systems to buy into a standardized protocol? What does the implementation look like?
- The Provincial HSJCC is working on restructuring and localizing implementation to be more effective at the local level.

# Presentation - Mental Health Court - Joanne Capozzi

• The slide deck is distributed with the minutes.

- The regular process of one-size fits all does not work well to address the needs of mentally ill offenders. A collaborative approach is used in the MH Court to produce better results.
- In Court 102, fitness testing took longer. Having a psychiatrist on site shortens the wait time for a fitness test, allowing for same day turnaround.
- Eligibility for Mental Health Diversion requires medical evidence.
- Mental Health Worker and Bail collaborate to address public safety.
- People who commit crimes in the following Divisions 14, 52, 51 and 11 can access Court 102. When there are exceptions, requests are made.
