The research examines how practitioners in various fields (1) understand interconnected social/medical/legal problems and (2) work collaboratively to negotiate working with clients who are often criminalized.

### **Lunch and Learns**

- The session on 'Changes To The NCR Legislation' with Justice Richard Schneider on October 29, 2014 was well received. An Evaluation was conducted and 94 per cent of respondents rated the session "Excellent". Lunch and Learn delivery methods were also surveyed. First choice among respondents was to have in-person sessions, followed by webinars.

# Presentation -Ryan Fritsch, Legal Aid Ontario Mental Health and Addiction Strategy

- PowerPoint presentation was distributed prior to the meeting and attached to the minutes.
- Legal Aid has started a formal consultation with the province and a new strategy will be released in 2015
- In 2012, LAO initiated development of a Mental Health Strategy with a fiveyear mandate, which includes a review of all LAO services with ongoing consultations involving stakeholders in the initial and ongoing development of the strategy.
- The MHS is looking at a broader definition of mental health and addiction and how it impacts a variety of stakeholders including how it intersects with LAO. It encompasses family law, criminal law, refugee law, clinic law, etc.
- LAO's mental health services are offered in a wide variety of contexts. Review all LAO services and mandate through a mental health lens.
- Reviewing client and service provider needs since mental health clients are not alike and different approaches are required
- Going forward, MHS is considering pilot projects for new and expanded services in community, courthouses and health facilities; training for all staff and empanelled lawyers; development of intake and triage tools, and more
- Relaxed eligibility and expanded legal coverage policies for clients with mental illness.
- Instead of the Certificate system currently used for lawyers, LAO is exploring more flexible retainer and certificate options to cover the extended needs for some clients and new certificates for MH appeals.

- As part of the consultation, the LAO has created a list of secondary consequences, which they will prioritize for future research
- Currently under development are staff training programs, updated panel standards, new and expanded programming and intake interview and assessment tools.
- The Strategy will give the LAO the opportunity to allow stakeholders to match their client's needs with programs and services
- The Strategy will look at cross-sectoral partnerships
- Considering a mobile legal team
- Ryan Fritsch was thanked for his presentation, the work he's been doing and his involvement on many committees

**Justice Collaborative** – Rhona Zitney reported on behalf of the Justice Collaborative. The Justice Collaborative is focused currently on the Reintegration Centre while College Park courthouse is temporarily deferred. The Justice Collaborative has been working with service providers to use a common intake and referral tool

**CRCT** - Rhona Zitney reported that CRCT is engaging in a health promotion psychoeducational group in partnership with the Ministry of Corrections and Community Safety. The group will work on life skills, culminating in a certificate.

- Program starts in December 2014. More information will be sent to Domenica Dileo for distribution
- Vesna Milinkovic reported that CRCT received new funding from the City of Toronto for the city's homeless to provide new housing workers with the goal of breaking the cycle of reoffending

**TSDC** - Katie Almond reported that she has not received any replies for a representative to attend a meeting to update the committee.

- She reported there are approx. 600 inmates at the TSDC.
- The Toronto Metro West staff are moving to the TSDC.
- Seconded staff have been asked to return to their home positions at the institution.
- Committee members expressed concerns that they have had difficulty communicating with the TSDC healthcare staff. Katie Almond will follow up and try to get a TSDC contact name.

**MCIT** - Gord Reid reported that the MCIT has expanded from Divisions 11 and 14 to

include Division 22. Division 22 is not full-time and is partnered with St. Joseph's Hospital
