Welcome and Introductions

Everyone introduced themselves.

Review of May 7, 2020 Minutes

The minutes of May 7, 2020 were approved with the following amendment: to change the organization name associated with Scott Skinner from Toronto Network of Specialized Care to Community Network of Specialized Care Toronto Region.

Review Action Items:

All actions items were reviewed and completed.

Annual Members Survey was reviewed. Discussion regarding meeting time and room change took place. Justice Mary Hogan suggested we can use room 155 when we meet in person. It was agreed to continue meeting from 8:30 am- 10:00 am.

Lunch and Learns

The next Lunch N' Learn will take place virtually on October 8. The topic is "Effectively Working with People using Crystal Methamphetamine" with Sanda Kazazic. All Local HSJCC members are invited to attend.

How is COVID-19 affecting service delivery in your organization, sector and/or community?

- Scott Skinner reported that Surrey Place, DSO opened four weeks ago for in-person assessments. The four offices will be opened for one-on-one following social distance rules, using masks and PPE. Using virtual healthcare system. There has been technology challenges for clients. He provided information regarding accessing court dates. - Natasha Bartlett reported that Fred Victor are seening more clients, and referrals are at normal case load, and they are meeting clients in the community.
- Katie Almond reported that Probation and Parole are connecting with low risk clients
 via phone; case load has decreased somewhat due to the courts being closed. It's
 challenging because many clients don't have acess to a phone or computer. High risk
 clients must report in person. They are providing lap tops and phones for PPOs to
 communicate with clients and agencies.
- Debbie Lynch reported that CTYS staff are seeing 20% of their clients in the communityin October that will be increased to 50-75%. Many of the youth do not have the technology for phone or virtual connection. Clients are more suicidal and using more drugs to cope.
- Amber Kellen reported that all of JHS sites remain open, as they have throughout
 the pandemic, other than the RST. They have been able to get some of their staff
 into the jails via professional visits. Very busy and frustrated by the delay re: reopening the site. Their call numbers have increased, and they are trying to
 manage the negative impact on their clients resulting from the pandemic along
 with the Opioid and housing crisis.
- Shane Rolland reported that the FOCUS Tables are continuing to meet and are dealing with complex clients with capacity and consent issues, as well having limited social service support. Video bail is taking place at Division 14 and have a court officer at the Division. Many are getting bail on their own recognizance, apprehention is slightly down. They are moving towards an advanced new software system. The station is closed to the public but are meeting people out front. Acknowledged that the landscape has changed.
- Justice Mary Hogan inquired whether the new software at the police station can track
 what is happening to people who are released under the new circumstances. It was
 acknowledge by Shane Rolland that tracking inquiries will have to be brought to the
 legal team. Who is studing the recidiivism rate? Katie stated that she would follow up
 with Corrections to see if anyone is pursuing this.
- Barbara Domenech reported that Cota are having increased contact with their clientsthey are being seen at their home. Alcohol use has increased among their clients.
- Robin Cuff reported CAMH addiction programs closed down and went virtual. Drug Treatment court was closed but are continuing to see individuals by phone and home visits. Their client numbers have gone up. Addiction medicine programs have operated

in altered ways. Court treatment court was given an extra person to do groups outdoor, and attendance increased.

- Janet Rowe reported that PASAN is doing food deliveries to clients, this is increasing
 connection. Virtual programs are not working for their clients. They are taking calls from
 folks inside the jail. They are seeing clients in the community and experiencing
 increased drug use and overdose. Completing funding application for release funding as
 they are receiving many calls. They are exploring to do outreach with the health bus.
- Judy Virgo reported that the Mental Health court diversion program is processing realease planning and working with Division 14. It is challenging meeting people faceto- face and/or do follow up because some people do not have housing.
- Cylene Rainville reported that LOFT is seeing clients in the community for support visits.
 Substance use has lead to increased neighbour disputes -- it is difficult for people to be isolated.

Themes discussed: It was suggested to review the EMDC inquest recommendations regarding overdose in jail. Janet R. will send the EMDC report to Domenica for circulation.

Legal Aid Barriers and Challenges

It was repoted that Duty Counsels are still on hold. They are focusing on clients who are in custody. The 48 hours expectation phone call has been challenging and it is being addressed.
