Welcome and Introductions

Everyone introduced themselves

Presentation: Emily Lam and Faisal Mirza on the Sentencing and Parole Project (SPP) is a non-profit organization that prepares enhanced pre-sentence reports (EPSRs) for Black people marginalized by poverty and racial inequality.

The Sentencing and Parole Project (SPP) is a non-profit organization that prepares enhanced pre-sentence reports (EPSRs) for Black people marginalized by poverty and racial inequality. Our work has built upon the use of the reports in Nova Scotia where they are ordered by the judiciary to assist with the sentencing of marginalized Black people.

- The reports give judges and parole boards the information they need to make informed sentencing and release decisions. They include recommendations for culturally appropriate programs to assist with rehabilitation.
- Provide enhanced presentencing reports. The social worker works with the
 defendant as well gathers information for a comprehensive report. They are
 trained in Anti-Black racism and how to approach recommendations through
 the lense of understanding people's expreinces. They are the only
 organization that provideds EPRSs.
- It was noted that the SPP provides training. Goal is to make the organization sustainable
- The SPP also trains justice system participants about racism in the justice system.
- Receive grant from the Law Society

Themes discussed: How can the HSJCC support your work? Share information about the organization and support sustainable funding at all governmental levels. Agency/Organization Updates

- Cylene reported on LOFT MHJI has receved new funding for a higher support site in the west end and have begun to take referrals. The housing is targeted to reduce recidivism for those with mental health issues and who would benefit from some on site staffing. Criteria is mental health diagnosis, and current involvement with the justice system, who are able to live in a shared space. Each client will have their own room, with common bathroom and kitchen facilities. Ideally, we would like to start with referrals from MHJI safe beds, probation, court support and forensic ACTT teams. All clients will be under a transitional housing agreement to start, with the possibility of permanent housing after the transitional period is up. The intake process will be the same as our regular MHJI housing, so this expansion of the program is not meant to be a crisis or shelter bed. They have 10 beds. Clients do not have to come through the Access Point and we will be handling the applications directly. The intake form will be circulated.
- Lindsay reported that there is a new phone system in jail and they can't make 1-800 calls. The new company is American. Katie stated that she will follow up regarding the new phone system.
- Robin reported that the COVID vaccine clinic have been successful. When they went to the TSDC 35% were vaccinated.
