## **Education/Webinar Options:**

- b. Alyssa Firely has developed an FASD Awareness Campaign via social media leading up to Sept 9<sup>th</sup>/22. Also expanding their Youth Peer Support Program and continuing to provide training to partner organizations and school boards. Firefly, in partnership with Community Living, will be providing training to Sioux Lookout OPP in Sept/Oct. It was suggested by the group that this type of training framework could be utilized and replicated across the province for other OPP and municipal police. Paola suggested training should be embedded in on-boarding processes for OPP and municipal policing services.
- c. Maureen Norwest CHC has planned annual community training for Oct 24th. Maureen will circulate event details once they are finalized. Training will be offered in-person this year. Norwest CHC used to provide specific training for police/corrections/justice system but this sector can be hard to engage. What can our working group do to promote education to these sectors?
- d. Alice delivered some training on Acquired Brain Injury and FASD during a police/Crisis team training a few years ago. Has also presented to Sioux Lookout's Health Community Task Force on Acquired Brain Injury's 101.
- e. Jenny Is it possible to utilize social media (eg. Tik Tok, YouTube etc) or self-directed learning options?
- f. CANFASD is a great resource.

g. Coordinated perspective would involve integration into other planning tables. Need to ensure coordinated efforts with MCRT Teams.

- i. Healthy Generations Family Support Program provides services to families in Sioux Lookout and surrounding area who are raising children with FASD
