- Went around the table to introduce ourselves
- Brandy Sands has replaced Kelly Falconer Niagara Rep at HSJCC Local meetings for now but will be more involved in future

  - Jaime could do the Thursday before or another day that week
  - Trevor week after is usually better
  - Will change to Friday, November 12<sup>th</sup>

## ACTION: Sherry to reschedule Nov 11th to Nov 12th

- Discuss the purpose of the regional committee, its' membership and agenda items (Trevor)
  - Attendance at meetings meetings often cancelled due to low attendance
  - If members don't feel the need to attend, what do they feel is the purpose of this committee?
  - Important that we have purpose or function that members find worth their time
  - Need to find our focus
  - Cindy
    - Relies on this committee for info and approvals
    - Misses having meetings when they're cancelled
    - Looks for feedback
    - Nice place to reconnect about what's happening in the area
    - Off today but at the meeting because it's important to her
  - Liane
    - It's become an issue since Terry left
    - With COVID, attendance was even lower

- In the past have done needs assessments and came up with a purpose – was useful but we haven't utilized the committee the way we could be
- A big issue that was addressed was lack of doctors willing to be involved with CTOs, etc.
- Maybe try needs assessment at local committees, identifying support needed at regional level, then get it to the provincial level

### Trevor

- A great function of the regional committee connects local committees with provincial committees
- Needs and gap analyses done but nothing came of them
- Same thing in Niagara a lot of work done but didn't go anywhere
- Would be good to pick one or two things each year
- A very successful action was getting the letter done for the provincial regarding court appearances by Zoom

#### Liane

- Was asked if there have been less fitness referrals since the pandemic started
- Might be good for the local committees to discuss what should be addressed at the regional meeting

### Jacquie

- When she started, Terry was retiring
- Meetings in Hamilton pretty large table and always quite packed
- Was able to attend most meetings at that time (less now due to unmanageable court schedules)
- Not sure we need a crown from every region
- Sometimes feels awkward as part of this committee but hopes to represent the link between the courts and the clients served by the HSJCC at the meeting
- Crowns want to serve clients better but with the pandemic, the amount of court time has set them back

#### Trevor

- Regional committee should be concentrating on things at a higher level than direct service
- Happy Jacquie attends our meetings because we should be looking at the policies, etc.
- In Hamilton the Local is a situation table
- In Niagara they look at case studies in retrospect
- We should be looking at how we can change things overall
- Having a member from the crown, gives us their perspective at the system level

- Liane
  - Maybe we relook at who we want sitting around the table based on their current roles instead of their location – did this before
- Jacquie a physician from a detention centre attended in the past would be helpful to have someone in this role on this committee
- Liane we should look at the list
  - ACTION Sherry will put a list together of the positions held by those that are on the list
- Satar no handover when he became the chair
  - Tyson representing court perspective is missed
  - Happy to continue anxious to get a replacement for Tyson
  - Looking for another chair for help from the court perspective
  - Hasn't been attending provincial meetings
  - Has asked to another regional meeting to get ideas
  - Ideas need to come from this group or the locals
  - ACTION Satar will work on getting local ideas
- Liane once Tyson is replaced, it will help
  - Everyone has to put an effort into the committee
  - Should be discussing with local tables, what to bring to regional committee
- Cindy local is quarterly
  - At the local level, they do what we do at the regional level
  - Not sure what this committee is for but it's a great resource & great for networking
  - Having Jaime attend her local committee was very helpful
  - Not sure what her local committees might be looking for regarding bringing issues for problem solving – doesn't know what that would look like
  - Looks at the regional committee for what she can bring back to her local committees
- Trevor No needs to bring to Regional committee? bring successes
  - A local system success might work elsewhere
- Veronica perspective from sitting on various local committees, clearly our areas are different, complicating information flowing in both directions, as well as membership
- Jaime manager of criminal law services in legal aid in Hamilton
- Satar Terry left some research that was done by a student
  - Does anyone recall it
  - Related to CTOs? efficacy of CTOs?
  - We're able to use students for that kind of work
  - Do you have a thesis type question that we could work on?

- Trevor Peterborough HSJCC funds a couple of students each year to work on projects
- Satar could be a valuable resource
- The regional committee will be covering provincial conference fees for all who register by Nov 2 2021
  - Group registration instructions have been sent out
  - People with lived experience can attend for free
    - Person needs access to a laptop or desktop computer can't use phones or tablets, etc.
  - Non-members are welcome to register for the conference
- Discuss experience of services supporting clients in other court jurisdictions (Cindy)
  - People with support from other jurisdictions likely due to existing relationships
  - Supports from other jurisdictions usually reach out to colleagues in the jurisdiction of the client
  - Niagara court supports will represent their clients if they have to appear in court in other regions
    - Need to build in processes to support the cross jurisdictions
    - What would it look like to build this in the back end?
  - Ok to continue to do this, regardless of where the court appearance is
    - Court doesn't care where the support comes from
    - Will take all the support they can get
    - COVID's forced some great changes ability to be supported virtually has helped a lot
- Discuss Police & MH project (Cindy)
  - Looking for some info on the details
  - Press release different than an MCRRT or Coast team but same feel
  - Brandy Niagara had one-time funding to put an MHW in dispatch
    - MHART team & MCRRT team (co-response)
    - 911 call triage process what team is more appropriate
    - One-time funding used for Quest Community Health Centre nurse
    - Didn't get off the ground but idea continues
    - CIT training for their dispatch team now
    - EMS hosting mental health worker and dispatch
  - Trevor presentation at the conference in November being done in Elgin-Middlesex
  - Satar If dispatcher feels a call is MH related, they will pass it on to Coast and our MHW takes over
    - Niagara does the same and have added a low priority 6 call for service with uniform – low acuity dispatch – all referrals go to Coast

- Jaime How are 911 calls triaged with regards to mental health
  - Depends on the circumstances
  - If criminal charges, the MHW steps out
  - Number 1 priority safety of person who's subject of the call and the people around them
- Satar question for Brandy how do you balance calls coming in from crisis line vs going to a dispatched call
  - Ongoing issue prioritized the crisis lines don't have the funding to have both
  - Sometimes crisis line receives calls from police to send out a team move people around as needed
  - Ongoing challenge
- Cindy question do we have a timeframe for when court cases will be in person again
  - Jacquie believes it will be hybrid
  - Starting in September, the presumption will be in-person
  - Other courts will continue to be by Zoom to reduce the number of people in the court room
    - Some courts find it more efficient to use Zoom
  - Starting jury trials again in September for the first time since the pandemic started
- Jen from an institutional perspective
  - Individuals will continue to have bail hearings and remands by Zoom
  - Before COVID started they were already doing a hybrid process
    - Not sure if it will change back now
    - Can't see ever going back to having bail hearings in person
    - Reduces transporting prisoners and reduces putting a lot of people in a small space
    - Only time appearances are in person when case is very serious or client has serious mental health issues – judge requires them to attend in person
    - Bail hearings will continue to be virtual in the near future
- Cindy Virtual bail hearings have eliminated the need for the "Red Envelope" program
  - They try to attend in person if their client is appearing in person

## 4) Update from Provincial HSJCC

- Not a lot of updates
- New junior policy analyst
- Community of practice transition from custody 90 or so people from across the province – let him know if you're interested

 ACTION Satar will look at workplans from last year and then ask people to contribute via email

### 5) Budget

- Spoke to Joel he will attend the next meeting
- Provincial HSJCC Conference
  - Most coordinating will be done via email
  - We have money in the budget
    - Virtual and much less expensive this year
    - Can send more people than most years
  - ACTION Trevor will send written version of registration form to Sherry
  - ACTION Sherry will send an email inviting anyone interested in attending, to fill in the registration form and return it to her
  - ACTION Sherry will accumulate and pay for all registrations at once
    - \$50 for Members of HSJCC
    - \$75 for non-members
    - Free for people with lived experience
- We have excess money due to the pandemic
  - Excess money from the end of the last fiscal year went to Barrett Centre to provide several hotel room beds every night
  - Brandy re-engaged conversation between CMHA, Jacqueline & courts talking about community treatment court
    - Making it Niagara appropriate will revisit in November exciting times
  - Trevor Talking with Niagara Region Homelessness Program to put together a working group to look at people who are discharged from the justice system & homelessness
  - Satar it would help if Brandy could share these documents she will be able to do that in November ACTION for Sherry – don't let her forget

## 6) Committee Member Updates

- Brant Local HSJCC
  - Steering committee has been developed and planning is underway for a Drug Treatment Court in Brantford. No start date set at this time.
  - Co-chair, Kim Woodward off for a maternity leave and a temporary replacement has been recruited from the membership – Dana Maddock (Legal Aid Ontario).
  - The 5 tablets purchased late last fiscal year have been distributed to community agencies and are being used pretty regularly for court appearances and client appointments.
    - Considering purchasing a couple more from this year's budget.

• With the exception of the Drug Tx Court subgroup, the committee is on summer break and we reconvene with a meeting scheduled for September 21, 2021.

### Haldimand Norfolk Local HSJCC

- Began Process Mapping (emergency and supported housing in HN) in June, facilitated by our areas System Manager, Mental Health & Addictions.
- We have held two meetings since June 2021 and work will continue throughout the summer.
- Once the ground work is completed a subcommittee will work through the "solution" brainstorming and community agency engagement portion.
- This is a large undertaking for the Haldimand Norfolk area with many considerations coming to light as discussions are held. The larger committee is on summer break and reconvenes October 4, 2021.
