

The Human Services and Justice Coordinating Committee Network

The Human Services and Justice Coordinating Committee (HSJCC) Network was established in 1997 in response to a recognized need in the province to coordinate resources and services, and plan more effectively for people who are in conflict with the law. Priority consideration is made for, but not limited to, people with a serious mental illness, developmental disability, acquired brain injury, substance use issues, and/or fetal alcohol spectrum disorder. The HSJCCs are a cooperative effort of the Ministries of the Attorney General, Children, Community and Social Services, Health and the Solicitor General.

Each HSJCC is a voluntary collaboration between social service organizations, community mental health and addictions organizations and partners from the justice sector. There are 14 Regional HSJCCs who work to improve the issues that impact clients regionally who require human services as they navigate through the criminal justice system. Over 30 Local HSJCCs provide education and training for their members, coordinate care for justice-involved individuals in their communities and provide input to regional committees.

The Provincial HSJCC functions as a planning body, supporting the individual and collective efforts of the Local and Regional HSJCCs. The Provincial HSJCC also identifies and addresses provincial service and policy issues, makes recommendations, and identifies system level solutions. Composed of regional members, representatives from the four supporting provincial ministries, and partner stakeholders, it is dedicated to education and training, provincial policy projects and system change initiatives.

Jennefer Simo

Community Support Worker, Indigenous Community Advisory Panel (ICAP) Member, St. Michael's Hospital

Jennefer Simo is a Community Support Worker at St. Michael's Hospital. Jennefer is an individual with lived experience both directly and indirectly, and she has family members who have experienced both addictions as well as mental health issues.



Katie Almond

Senior Program and Policy Advisor, Oversight and Accountability Unit, External Oversight and Compliance Branch, Operational Support Division, Ministry of the Solicitor General and Provincial HSJCC Co-Chair

Katie Almond has been working in the criminal justice system for 35 years, 31 of which have been as a Probation and Parole Officer with the Ministry of the Solicitor General. For 17 years, she has worked with a client population that is marked by poverty, homelessness, mental illness, physical and developmental disabilities, and polysubstance use. From October 2016 to January 2018, she was seconded to the Corrections Psychological Health Unit, working on mental strategies for both staff and clients.

During the course of her career, Katie has been involved in the development of extensive community networks and collaborative initiatives. She is the Co-Chair of both the Downtown Toronto, and Provincial Human Services and Justice Coordinating Committees. She is also a member of the Board of Sound Times Support Services; the Community Justice Court Initiative Committee; the Discharge from Court/Red Envelope Committee; the Client Mental Health Strategy/P&P committee; the CAMH Constituency Council; the Advisory Committee for the Criminal Justice and Developmental Disabilities Project; and the Acquired Brain Injury and Mental Health Advisory Committee.




Sara Dias

Pat also served as cochair of the Toronto Police Board sub-committee on mental health. She serves as a part time member of the Consent and Capacity Board, is the author of seven books, five non-fiction and two mysteries, and is a recipient of the Order of Canada, the Order of Ontario, the Queen's Jubilee and the Diamond Jubilee medals, and the Hincks Award from the Canadian Mental Health Association.

Dr. Tim Aubry

Faculty Research Chair in Community Mental Health and Homelessness, University of Ottawa

Dr. Tim Aubry is a Full Professor in the School of Psychology and Senior Researcher at the Centre for Research on Educational and Community Services at the University of Ottawa. He is currently holder of the Faculty of Social Sciences Research Chair in Community Mental Health and Homelessness. Over the course of his career, Tim has collaborated on research projects with community organizations and government at all levels, contributing to the development of effective social programs and policies. He was a Member of the National Research Team and the Co-Lead of the Moncton site in At Home / Chez Soi Demonstration Project of the Mental Health Commission of Canada.

In 2013, he received the Contribution to Evaluation in Canada award from the Canadian Evaluation Society. He is a Fellow of the Canadian Psychological Association and the Society for Community Research and Action (Division 27 of the American Psychological Association). Tim is currently the Co-Chair of the EENET Ontario Housing First Regional Network Community of Interest. He teaches graduate courses at the University of Ottawa in community psychology and program evaluation.


