- d. Court-** Courts want people to attend Court Appearances via zoom or phone. Lindsay Court information was put in envelopes and sent to Minden in error. Minden learned the Crown was giving our wrong information. Wrong: to zoom into Lindsay Court, time slot ; 2hrs, phone-in number for urgent matters 11am-1pm, acknowledge court times, making contact. The number posted on the Minden Court House door is the correct number to call. Todd is attending Minden Courts via phone, to help. Warrants have not yet been issued for people not calling in. Todd is concerned about those who have technical challenges. Minden's Court cases are still not being dealt with. Use 1-800#s for Duty Council. Get Disclosure by email. Clients are to go into the website for Court times, court rooms. Youth Court in Lindsay is dealing with Minden Youth Court matters via zoom. This is NOT the same number posted on the Minden Court House door. Youth Court calling in. Court is public so anyone can zoom in and observe. Youth's names are not posted in newspapers.

High school optimum courses, 22 day course cycles, a couple of course every day-intense. Alternative Education-same as usual, online offered too. Stressful studying from home as looking after their own kids or siblings while parents go to work. Technology-Ministry says they have iPads etc, but none have

<p>been received here and not seeing any new technology on the way. Food Program was shutdown, can't use microwaves or kettles. No Breakfast Clubs, can't serve yogurt because can't keep it refrigerated. Families are not packing enough foods/snacks because they are used to the food programs that are not available now. Food Net-Arron says there is money for food but not for distribution. SISCO snacks are full of salt and sugar –not healthy. Financial issues for families. In schools; Mental Health-google meet. Need to see people they talk with, there are trust issues. Can't go into schools to help with mental health issues, or presentations. Todd connected Jack Veitch with School Board- an excellent engaging public speaker, especially with youths.</p> <ol style="list-style-type: none"> 1) Safe Connections-biggest deficit. Students not getting the help they need to get through a 22 day course. 2) Seeing very gaunt, not just thin looking students this year. Students can't get into town to get food from Sirch <p>o. YWCA- Located in a yellow box beside the door in Minden, is an afterhours Direct Phone Line to Crossroads Woman's Shelter in Peterborough. YWCA is helping with housing etc. MHCC Transitions Support Survey by region- complete by HSJCC, Darlene will send it to Andrew.</p> <p>p. Mental Health- SafeBeds is open after the fire, still taking people, but are down to 4 beds. Things are very busy as people are worried about housing as winter approaches.</p> <p>Mental Health is starting rotation with groups, art, knitting, anxiety & depression groups and men's group. Brock Dixon the facilitator is looking for to start a younger men's group for those ages 26-34. Stats show the majority of suicides are men over 45 years of age due to a lack of socializing.</p> <p>q. Brain Injury(clients 18yrs-65yrs) – Creating more zoom programs. Looking for more Anger Management Resources. Jasmine Knoche was recommended as well as ABI FYI facilitator Nicole Nadeau (OT).</p>
