2. Review and Adoption of Minutes – September 24, 2015

- Presentation by Nancy Falls, Thrive Child and Youth Trauma Services:
 Sexual Offence and Behaviors with Youth
- Update on Provincial Conference/Prov. HSJCC information
 - There are currently 27 registrants for the upcoming Provincial Conference. If you have not yet registered but would still like to attend, please contact Terry.

 The Province is tightening processes governing regional and local committees, and is looking to prioritize objectives. A SWOT analysis for our Hamilton HSJCC identifies:

Strengths:

- Having a stable, long-term committee chair
- ABI Working Group
- Facilitating support for detention centres
- CTO's possibly highest use in the Province, effective tool to engage clients in care when all other interventions have been exhausted
- Reduction in ER waits for officers
- Meet regularly (monthly)
- Mood disorder rep

Weaknesses:

- Detention Centre representation has been weak
- Long wait lists for services in the community

Opportunities:

- Re-involvement with detention centre
- Presentations
- Situation table
- Dual diagnosis report > available on Provincial website

Threats: None identified

- The LHIN 4 Regional committee identifies the top 3 priorities for our area as:
 - 1. Ongoing supportive housing for those with behavioral issues
 - 2. CTO's
 - 3. Psychiatric consultation and follow-up.
- Re: CTO's: Fiona stated that less coercive methods are preferable to guide people toward treatment <u>FIRST</u>, and if that doesn't work, <u>then</u> CTO's should be utilized.
- There was discussion on the CTO's as it relates to clients who are incarcerated. Liane consulted Dr. Ferencz, and his understanding is that the detention centre never treats people against their will

while they are in custody. She also consulted Dr. Chaimowitz, and he expressed that the person under a CTO while in custody must be transported to hospital for treatment (if refusing treatment), and then returned to custody.

- Fiona asked for clarity on this issue re a legal obligation to continue treatment if the client refuses; does the jail have to send people to hospital? Liane agreed to clarify further.
- Barb said that the detention centre wouldn't always know if a
 person was on a CTO when they went into custody. Heather P.
 asked if the superintendent could be added as a party to the CTO.
- Barb to explore this question with super intendant at HWDC as the detention center is moving forward on some policy changes and will get back to the committee re next month: CTO's being continued while in detention centre.
