• Welcome and Introductions

Lori Dunne welcomed everyone and introductions were made around the table.

New Members

- Lori Dunne welcomed new members Emily Smith from Good Sheppard Youth Services and Danielle Newton from Contact Hamilton
- Emily Smith from Good Sheppard Youth Services Notre Dame House provided the table members with a handout outlining their community mental health program (see attached)
 - There has been an increase in the following:
 - mental health issues for youth
 - Domestic abuse among young couples
 - Duel diagnosis
 - Population Served Homeless/at-risk of homelessness and streetinvolved youth between the ages of 16-21* residing within Hamilton
 - Referral Process Youth can be referred via self-referral or through fourteen unique services provided through the city of Hamilton
 - Referral form and Interai Screener Plus tool required for referral
 - Program does not maintain a wait list
 - Therapeutic Intervention Upon being assigned to a Mental Health Clinician each youth works to develop a tailored treatment plan and works with their Clinician in attaining their mental health goals. Youth have access to individualized brief, evidence-based, focused therapy and the skills 4 life group programming grounded in cognitive and dialectical behaviour therapies
 - Youth are initially offered 6-8 sessions however based on the complexity of the presenting needs may be offered ongoing support with a Mental Health Clinician from upwards of six months to one year
 - Clinical Case Management All youth accessing the Community Mental Health Team are supported in clinical case management including but not limited to community program referrals, liaison with existing clinical supports, applications for DSO, ODSP and related programs, and transition management
 - Specialized Consultation Youth connected with the Community Mental Health Team have near-immediate access to psychiatric and psychological support. Youth may be eligible for special funding for the completion of a psychological assessment and report
 - Notre Dame House Centralized Services
 - Youth Housing Workers
 - Legal Clinic (LAO)
 - Substance Use Counselling (Alternatives for Youth)
 - Youth Trustee Program
 - Ontario Works/ODSP

• Review and Adoption of minutes from November 22, 2018

• Additions to Agenda

There were no additions to this month's agenda.

• Presentation: Trans Inclusion (Cole Gately)

- Cole Gately spoke to the table regarding Trans inclusion (see attached PowerPoint)
- Some of the topics discussed:
 - > Fears or anxieties clinicians have when engaging and supporting trans people
 - Using the incorrect pronoun, especially if someone changes their preference
 - Not wanting to upset or offend a client by mistakenly using the wrong pronoun
 - Cole made several suggestions for reducing these fears
 - Introduce yourself first using your preferred pronoun
 - Try not to get hung up on using the wrong pronoun
 - Use "they" instead
 - Use last name only
 - > Commonly used terms and there definitions
 - Trans Transgender people have a gender identity or gender expression that differs from their assigned sex
 - Gender-Diverse A person who either by nature or by choice does not conform to stereotypical gender-based expectations of society
 - Non-Binary Any gender identity which does not fit within the binary of male and female. This term may be used as an umbrella term or as a personal identifier
 - Genderqueer Term that can be used either as an umbrella term or as a personal identifier. This term refers to people who do not subscribe to expected gender norms. Gender-queer people may identify as either male, female, both, neither or may reject gender altogether
 - Intersex A person who has male and female genetic and/or physical sex characteristics. This term sometimes refers to a medical condition, a gender identity, or a political identity

- 2-Spirit English language umbrella term originating from the Ojibwe phrase "niizh manidoowag" which represents a wide range of diverse gender roles found in some First Nations and Indigenous cultures. This concept may incorporate spirituality, sexual orientation, gender identity and/or gender expression
- Cisgender Refers to individuals having a gender identity that is congruent with one's sex assigned at birth (e.g. both sex assigned at birth and gender identity are female)
- Heterosexism Discrimination or prejudice against homosexuals on the assumption that heterosexuality is the normal sexual orientation.
- Cissexism Set of acts and norms that privilege cis people and/or oppress trans people. More broadly, cissexism is the appeal to norms that enforce the gender binary, and gender essentialism, resulting in the oppression of gender variant, non-binary and trans identities
- "Passing" Applies to a transgender individual who is generally perceived as cisgender. Typically, passing involves a mixture of physical gender cues (for example, hair style or clothing) as well as certain behavioral attributes that tend to be culturally associated with a particular gender
- TERF Short for "trans exclusionary radical feminist". The term is used by trans advocates to describe feminists who oppose the inclusion of trans women in female spaces and organizations, whereas those it is applied to see it as a mischaracterization of their positions and a slur
- > How can individuals be an ally to Trans persons?
 - Fostering a gender affirming environment
 - Training all staff on Trans inclusion
 - Employ Trans persons
