• Welcome and Introductions

Jill Pollock welcomed everyone and introductions were made around the table.

• Review and Adoption of minutes from December 20, 2018

The minutes were reviewed and no changes were brought forward. Fraya Mortensen approved the minutes and Steve Holmes seconded the minutes.

• Additions to Agenda

- Provincial HSJCC call for abstracts
- Presentation: Virtual Reality Tool (Brandon Sunstrum SJHH Knowledge Translation Specialist)
 - Brandon Sunstrum discussed the virtual reality tool and provided a demonstration
 - Currently three scenarios are being used for the training and orientation of staff:
 - 1. Prison Segregation Cell
 - From the perspective of an individual in segregation
 - Simulation lasts up to an hour
 - Participant can knock/bang on the walls, but no one answers
 - 2. SJHH Seclusion Room
 - Participant must get attention of staff in order to use washroom which is located outside of the seclusion room
 - Creates empathy towards clients when putting them into seclusion
 - Emphasizes difficulties of getting staff attention
 - Various responses are given by staff i.e. "Calm down", "We can't let you out if your yelling", or no response at all
 - 3. Patient Room at SJHH
 - There are hidden contraband items in the room which needs to be found by staff
 - Provides staff with a sense of the popular hiding spots clients use
 - Helpful resource when staff are performing client room searches on inpatient units
 - A fourth scenario which depicts an inpatient unit at night with an unknown patient screaming is also currently in development
 - SJHH would eventually like to share this technology with corrections and other agencies

• Updates

I. Other presentations/speakers - Jill

- Chelsea Chesson and Jennifer Schultz-Stowe from YWCA will be presenting on the Snoezelen Room in February
- Also in February. Lori Dunne will be presenting an overview on the 3 HSJCC levels (Provincial, Regional and our Local Hamilton table) regarding the function of each table, funding, and how they inter-relate with each other.

II. Standardization Updates – Jill

- A new student will be starting with Lori Dunne on Jan 7, 2019
 - His name is Toby Merritt
 - Will be working on 2 LHIN projects:
 - Reviewing Case Management Models (local-to international)
 - Looking at Mental Health and Addiction protocols across Ontario in non-schedule 1 facilities. There are 3 non-schedule 1 facilities in our LHIN and we are looking to see what we can be done to improve our model, transfer to schedule 1 facilities and best practices.
- The COAST/MCRRT documents are still in the re-formatting stage and will go out shortly for the 2nd (last review)
 - After 2nd review is complete, we are looking at finalizing
 - Will also be working with OPP at creating documents/protocols from a Provincial lens.

IV. Membership Engagement – Jill

- Lori Dunne and Jill Pollock met to discuss our HSJCC Local table
 - Looking at different ways to increase the table's function and operation
 - Have been trying to schedule guest speakers or education-based information sessions at the beginning of each meeting; however, it's unclear whether or not this is helpful or of interest to members
 - We'd like to hear your input so that it becomes a shared table that meets the majority's needs
 - A short 2-5 minute survey will be developed and dispersed to the members
 - Questions will include, "what do you like about the table, what is not working well, what content would you like to see, what speakers/education sessions (if any) would be of benefit
 - We'll try to make this survey available online and anonymous
- It was also discussed about increasing membership engagement
 - Membership attendance has always been exceptionally good, or high, but the work done within the table has really been limited to Provincial systems updates and client cases. The response rate for working on subcommittees, special projects, and HSJCC work plans has notoriously been low, and it's challenging to operate a table this way. We're reaching out to other HSJCC tables to see if there are unique ways in which their members are engaged.
