CTO Project Update

Karen McLeod read report regarding results of the investigation conducted. The report is attached.

- o The report revealed that there has been an increase in the number of people who are in the criminal justice system with severe mental health issues who need assistance. Members looking for possible solutions in order to reduce these numbers.
- o The report validated that HSJCC committee was beneficial in assisting these clients by looking for solutions in helping to provide better care.
- The CTO presence increased an individual's cooperation with medical treatment and access to community services.
- Community agencies were more confident in assisting risky individuals when CTO was involved.
- o Increased access to community services and receiving support.
- Enforce Form 1 A treatment plan to assist individuals with medication.
 They are given 2 choices to either take their medication or they will be reported.
- o Some benefits of individuals on CTO:
 - o Police can assist the individual to see their mental health worker to continue with their treatment plan rather than readmitting them to the hospital or arresting them.
 - Decrease police interactions or individual becoming known to police which increases their risk of arrest.
 - o If an individual is on a CTO, it may make a difference on the judge's decision when passing a sentence.
 - Individual who is incarcerated is more likely to be taken to the hospital to receive their injection which decreases their chances of becoming unwell.
 - o CTO involved in discharge plan after incarceration for individuals with higher risk factors.
 - o Decrease in administrative offences (breach of probation).
- Lisa will be writing to the Ethics Committee for changes.
- Lisa is writing articles and making posters for CTO. If any group is attending a conference, let Lisa know. She can provide you with a poster to display at the conference regarding CTO services.
- Advocate for CTO to be enforced for people who are incarcerated.
- Suggestion was made to have a representative from HWDC Operations at the table. The process of handling individuals should be consistent.

Program Updates

- Southern Network -
 - Alison Hibbett's representative will be starting on July 2^{nd.}
- HWDC 4 addiction nurses have been hired bringing the total to 6. There will be additional training for addiction nurses available.
 - o Katrina, new Addiction Counsellor will be responsible for preparing the individuals discharge planning.
- A suggestion was made that Wayside be invited to table. HWDC has experienced some difficulty when transitioning people to Wayside.
 - o The same procedure should be used for the whole institution.
 - o Process should start with the nursing unit at HWDC with an assessment followed by a plan of care.
 - o If you are not sure what to do, then contact someone you know at HWDC and they will direct you or fax referral to 905-523-7417.
- Correctional beds are at St. Joe's.
 - o Correction officers will not be onsite.
 - o 4 Forensic beds delayed due to construction.
- Barrett Center 5 new beds now available.
 - o Accessible by COAST, MCRRT and frontline police.
 - o There will be a 30 day follow-up after individual leave.
