# Additions to the Agenda

- o Zoom will be a permanent option regardless of pandemic situation
- Perhaps have quarterly meetings in person
  - All in agreement
  - Next meeting is in September will be a virtual meeting
  - Will review when we'll have in person meetings depending on Covid
  - Will still have a virtual option available during the quarterly meetings in person
  - Will use in person meetings for presentations, etc., as well as having lunch
  - We are gaining momentum now that it's easier for people to attend the meetings

# • Program Updates

- HWDC
  - Kari Zammit is starting a 9-month secondment
  - Jennifer Johnston will replace her as manager of Social Work & Rehabilitation and will take her place on the committee
  - Replacing Jennifer's role on the committee is Ainsley Howard
- Virtual Court September 21st is the target date
  - Case Management Court, which includes first appearances for most of the criminal cases affected by COVID, hasn't resumed since March for anyone in custody
  - Will be virtual exclusively over Zoom
  - Will allow individuals to call in if they don't have internet or access to webcams
  - Will be a lot of confusion when it starts
    - People won't know their court dates
    - Have been adjourned twice in the 10-week adjournments
    - Experience in other jurisdictions that have piloted this, has been less than 50% attendance
    - If they don't attend, they will be adjourned again
    - Summons will be issued
    - For groups on this committee with clients looking for this information, there will be communication coming from the court that will give some clarity to what court dates are (Andrew or Tyson could forward the information to everyone at this table) no database available that you could look up on the internet to find the dates can use this information to track back to when your first court date was during this time period and then you can figure out the new court date from there
    - There might be access to telephones or tablets and various programs
  - Ontario Court of Justice website has list of remand dates for individuals that are in custody – <u>https://www.ontariocourts.ca/ocj/</u>
  - Had some success with calling the Crown's office but this isn't likely to be a good option due to the volume of calls
  - May have clients that have court cases coming up the Ontario Court of Justice website can be very helpful
  - Call Tyson any time if you have any questions about a particular client who has court dates coming up and he would be happy to assist

- o SJHH Forensics
  - Acute Stabilization Unit
    - Was about to start before COVID
    - Officially opening it on September 9<sup>th</sup>
    - Will allow people in custody could come to St. Joe's for a period of treatment and stabilization and then return to HWDC
    - For admissions will be direct from HWDC first admission on Sept 9<sup>th</sup>
