For individuals in the CJS, similar to a Common Roof scenario, and looking to eventually make this a province wide initiative. Only in plans currently. • Also discussed were the Indigenous Engagement Survey and feedback on Indigenous Support Services, the goal is to have representation from Indigenous Support Services from all communities on all committees. • Network Member Engagement Plan. Jean-Marc suggested that all members please read this. Strategies shared for member engagement. Improving engagement should be a collaborative effort.
