## **Review of November 2, 2018 minutes**

Minutes were approved.

Presentation: Roberto Lasci and V. Dudarin on MCIT

- Slide decks will be circulated to members
- MCIT stands for Mobile Crisis Intervention Team. Each team consists of a specially trained police officer and a mental health nurse. Nurse employed by the hospital. Will attend in response to a call from a Priority Response Unit
- Mandate is to: Enhance the quality of service delivered to persons experiencing a MH crisis; provide a secondary response to incoming calls for service, follow-up, and referrals; remove the individual from serious harm to themselves or others; make an immediate on site clinical assessment of the person in crisis; and arrange appropriate mental health treatment through referral or apprehension under the MH Act.
- Operates seven days a week from 11 a.m. and as late as 9p.m.
- Do not lay charges, priority is to keep people in the community

- Themes Discussed If there is an assault due to MH can MCIT express opinion not to press charges? It was suggested when issuing a Form 2 that individuals/family members involved to go with the client to the hospital because this can provide context when Doctor assesses the patient to improve outcome.
- Can there be a mechanism regarding how to provide feedback to police and/or JP addressing Form 2 situations? It was suggested to bring lack of Form 2 feedback mechanism to the Toronto Regional HSJCC for further input.

**Presentation:** Superintendent Scott Gilbert and Officer Brian Smith on Focus Table

- A collaborative risk-driven approach to community safety and well-being
- Acute Elevated Risk (AER) Situations is a reference to any situation impinging on individuals, families, groups or places where circumstances indicate an extremely high probability of the occurrence of harms or victimization.
- FOCUS Situation Tables at the Local Level brings together the most appropriate community agencies at a weekly situation table to provide a targeted, wrap around approach to the most vulnerable individuals, families and places that are experiencing heightened levels of risk in a specific geographic location.
- FOCUS Toronto supports local situation tables with coordination, administration ad special tools that strengthen outcomes for vulnerable populations.
- FOCUS Toronto Steering Committee provides strategic oversight of the operations of the FOCUS Toronto
- How does it work? A multi-agency team meets once a week to identify individuals, groups and places that are at high risk. The first element of response happens between 0-48 hours following a meeting.
