### **Lunch and Learns**

- The March 20<sup>th</sup> Lunch and Learn on System and Community Perspectives on Opioid Overdose was successful with Dr. Samim Hasham, Robb Johannes and Anu Sharma, Health Promotion Specialists. Total of 95 people registered and 56

attended the webinar from cross sectors plus 13 at the courthouse. Video link was circulated.

- Andrew Graham is working with Dr. Gojer for a Fall Lunch and Learn. The topic will be Keeping Sane in an Insane World. January 2018 a Lunch and Learn on various levels of malingering.

- What is SS&A – Implementation of a new staged screening and assessment process in all publicly- funded (Ministry of Health/Local Health Integration Network) addiction programs in Ontario.

- Next Steps – development of web- based learning for GAIN Q3 MI ONT assessment tool, ensure people have access to the new reports, tool changes based on feedback, analysis of system level data and shifting to full implementation
- OPOC-MHA standardized validated tool, empowers service users, working in all 14 LHINs, implementation coaches working with agencies to develop agency action plans. There are two version of the tool. One with 32 questions and for non- registered there are 17 questions. The tools do not address substitution decision making.
- The tool has been translated into five languages.
- Themes discussed: Data can be shared and used for funding. Trainers to commit for two years term.
