Presentation: Scott Skinner on Community Network of Specialization Care – Toronto Region

- Presentation slide decks will be circulated.
- Mandate: To serve adults with developmental disabilities with complex and multiple needs
- Discussed key functions and roles, target population, complex support coordination, health care facilitator, dual diagnosis and Justice case manager, behaviour facilitator, service pathway, shifting to improved consistency in planning functions, connection across sectors
- Dual Diagnosis and Justice Case Manager can access the Developmental Service Ontario (DSO). If eligible can access the \$5000 fund. Work collaboratively and support court diversion for people with developmental disabilities and/or dual diagnosis
- Coordinate a continuum of services to plan appropriate discharges and maintain community engagement
