# Medical Files Transfer Fee Survey:

Domenica reported that 17 members completed the survey from four locals and one regional table.

The following question was asked: Have your patients/clients experienced payment to transfer their medical files in order to access medical care?

From the respondents we had a large range 30- 70 clients in the last 12 months had to pay a fee to see a new family doctor for their transfer.

Survey results will be brought to the regional table for discussion. It was noted that hospital to hospital file transfer do not charge a fee.

# Presentation: NPower Canada with Sheryll Smith

NPower Canada launches youth (18-29) into meaningful IT/Digital careers by providing free technical and professional training, paid internships, job placement

and post hire support. NPower Canada currently offers two different training streams in three locations across the GTA (downtown Toronto, York Region and Peel Region) and in Calgary, Alberta. They work with the mental health and addictions communities.

The program is free and runs for 15-weeks.

Eligibility: Participants must be finished highs school, demonstrate financial needs, may have criminal records, mental health and or addiction issues, are legally able to work in Canada, have strong English language proficiency, are

unemployed/underemployed, are motivated to find work.

The customer services digital program is only offered in Toronto.

These programs are funded by industry, mainly RBC and United Way. NPower is a non-profit organization.

Graduates' certificates are accepted worldwide.

90% of participants have work after graduation.

Offer support for 5 years after getting a job.

# **Agency/Organization Updates**

- Tammy Tinney reported that NYG Hospital, Mental Health and Justice Treatment and Support Services are narrowing their criteria due to the lengthy waitlist. They are no longer talking referrals from case managers, doctors or hospitals. Catchment area only the GTA.
- Will not take referrals if one has ADHD, substance use issues, sexually related offences will be reviewed on case by case basis.
- They are taking referrals only for people connected to the justice system.
- Dina Zalkind reported that due to the significant Legal Aid budget cuts services have changed. Courtroom 301, 302, 303 no longer has a Duty Counsel. They are doing a financial test, if one does not qualify they can only provide advise. Private Counsel are not paid for bail hearing; Duty Counsel are now doing most of them.
- Laura Van Harmelen reported that CMHA is in the process of building more safe beds. The four safe beds are not utilized by police and/or MCIT. Exploring engagement options.
- Justice Riun Shandler informed the committee that the courthouse has psychiatrist for fitness testing.
