Business Arising from the Minutes

- Susan Adams reported she is still working on getting representation from Court Services to attend the meetings
- She spoke with the Toronto East Detention Centre with regard to their medical disbursement procedures to ensure continuation of medication. She was told that the procedures are on a per-case basis.
- The Toronto East Detention Centre prefers that if a client needs medication that Health Services be contacted prior to release with the name of the pharmacy and they will send the prescription. Three hours notice is required in order to have doctor prescribe medication.
- There is not a designated person at the East Detention Centre the person answering the phone at the health services will provide the necessary information.
- Andrew Graham will get information from TSDC with regard to their medication disbursement procedure.

It's considering moving the length of stay from 30 days to 14 days in order to include more people into the program due to the length of the waiting list. The length of stay does not change where people move to. Due to the lack of available housing people move from the safe beds to

- shelters. The committee supported the initiative but asked that there be flexibility based on individual needs.
- Scot Hodge reported that Anastasia Calim is replacing Stuart Goldman as the Clinical Team Manager Adult Mental Health and Branson Site Leader at NYG.
