The NY-HSJCC works collaboratively:

**I.** To assist in developing and maintaining an accessible and well-functioning system of mental health, justice and related services that work together to improve the transition between services within the sector of the Committee's target population, to and through the services and supports that they need, when they need them.

**II.** To assist to improve the quality of services for individuals with mental health and substance use issues who are involved with the criminal justice system, including the specific matches made between clients and services both initially and through clients' individual recoveries over time.

**III.** To assist to minimize the amount of time people spend in correctional facilities waiting for assessments, (e.g., fitness, Form 6 and/or services they need to support their safe, successful release and re-integration back into the community).

**IV.** To assist to identify barriers to achievement of any of the above objectives, with a particular foci on identifying and addressing barriers at the interfaces between the mental health, substance use, criminal justice and related systems.

**V.** To assist in reducing recidivism.

**VI.** To improve the experience of equity seeking and racialized groups; recognize, support and engage with Black and Indigenous communities within the efforts of the North York HSJCC OR in accordance with the mandate of the North York HSJCC.

**VII.** To promote self-awareness/ reflection through education and dialogue about the equity impact of social determinants of health and how they may manifest in the work of the North York HSJCC.

In addition, the NY-HSJCC Co-chair(s) are active member of the Anti-Racism Ad Hoc Group that developed and implemented a five-session educational series on Anti-Racism to improve the experience of equity-seeking and racialized groups. Furthermore, we continued to pivot to online activities where possible.</p> <p>The NY-HSJCC Co-chairs attend the Toronto Regional HSJCC meetings. They report on the NY- HSJCC's identified issues and priorities resulting in increased coordination and collaboration by building capacity and sharing responsibility.</p> <p>Member evaluations were completed and/or anecdotal feedback was provided, demonstrating increased participation with HSJCC and coordination between human services and justice sectors. <b>Key Outcomes</b>	<p>The Toronto Regional HSJCC established an Anti-Racism Ad Hoc Group to address Anti-Racism in the context of the HSJCC mandate working collaboratively among the Locals. The NY-HSJCC Co-chairs are active members of this group, who developed and implemented an Anti-Racism Lunch and Learn series of 5 sessions. The NY-HSJCC Co-chairs report to the Locals on the activities of the Anti-Racism Ad Hoc Group.</p> <p>This year the NY- HSJCC collaborated with the Toronto Regional to implement and lead Lunch and Learn sessions that aligned with the identified interest of its members. These joint sessions increased the number of participants per session. Participants had the opportunity to ask questions and/or discuss situations that can be explored.</p> <p>These sessions were: Anti-Racism Foundation 101 &amp; Professional Perspective</p> <p>In addition, the NY-HSJCC had a Lunch and Learn sessions on Gladue: What it is &amp; Why it Matters, 188 people attended this session, and 573 registered.</p> <p>410 participants attended the three virtual Lunch and Learn sessions. Last year 316 attended three virtual Lunch and Learn. There was an increase of 30% from the previous year's Lunch and Learn attendance.</p>
