- 1. Reviewed criteria for admission and provided overview of program.

Of note, neither COTA nor DC were aware that individuals could be referred to the clinic for potential Mental Health Diversion (an exception to the general rule that referrals are accepted for individuals with no pending charges either after a finding of guilt or for people not currently legally involved but who are at risk of coming in contact with the law).
- 3. Referrals can be done by probation & parole officers, medical doctors or mental health case workers.
- 4. New program "Talking for Change" for prevention of sexual offences against
- 5. Probation conditions at times problematic as they restrict the individual's ability to use internet and counselling/therapy sessions are largely done online now.

# How is COVID-19 affecting service delivery in your organization, sector and/or community? /Agency and Organization Updates

- Tammy advised of a recent issue with probation conditions. While this hasn't been an issue in the last number of years, recently she had three separate clients with probation conditions prohibiting them from possessing or consuming substances. This is a problem as clients would have a hard time completing counselling if they cannot openly admit to substance use, and they are worried about disclosing such use for fear of being breached. Christie indicated that she also has one client with this issue (she, too, hadn't seen these conditions for the last 4 years or so until this client). Christi suggested speaking to the clients' probation officers, but Tammy indicated clients are reluctant to have this discussion and don't want her to reach out. Christi will let CLOs at Metro North know as well.
- Tammy advised that Rose left and they will have a new part-time worker (Violet) 3 days/week. Current case load is very high and they are unable to accommodate individual anger management counselling if that is the sole purpose of the referral (though would continue to provide such counselling if bundled with other issues).
- Andrew G. advised that Lynda is moving to a new position and COTA will have a new worker replacing her Victoria Young, who is currently in training.
- Andrew M. advised that COTA is currently doing its own anger management program in-house it is free and run by him.
- Genieve advised that Bail Program has a new court worker for 1000 Finch Cathy Lee. Amber is currently covering TSDC for Carol, who is on leave. Imtiaz continues to be the Enhanced Bail Program worker and is starting to see some clients in the community.
