#### **Land Acknowledgement**

Tammy noted the Land Acknowledgement recognizing the history of the Indigenous People and their contribution to the land we stand on.

#### **Welcome and Introductions**

Everyone introduced themselves.

Presentation: Rebecca Walker, Christine Gregory and Andrew Gartner, from Sound Times.

- Rebecca provided the historical context of Sound Time. The agency was created in 1992 and was part of the Community Resource of Toronto Social Recreational Club. They are an Adult Consumer Survivor of the mental health system. At this point they had 50 members. Today they have 1800 members. In 2002 they moved to their current Parliament St address (south of Dundas). The centre is COVID friendly. They remain opened during COVID, using a Kiosk model, as well, following public health guidelines. Ten people at a time can use the centre.
- Christine discussed the following aspect of their support: can help with same day needs, members driven organization by and for consumer survivors, provide a warm environment, the Self-Management Recovery Training (addresses addiction) is in person program on Monday Friday at 11:00 am. It will be indoor during the winter. All services are voluntary and use a 360-team non-clinical approach. All staff can help individuals as needed as well provide snacks for people to take with them. Also have Fun programs such as; Friday music listen party, joke club and art group.
- Andrew reported on the general practitioner clinic: There are two doctors and a nurse exclusive for their members, as well as a psychiatrist. Currently, psychiatrist

- appointments are booked for the third week of December. OW and ODSP are making many referrals for assessment which limits the availability when one can see the psychiatrist.
- Referral process: mainly self-referral or agency referral. They are part of the Justice Community Centre pilot project. They have a case worker as part of this project.

**Themes discussed:** How quicky can you serve an individual who was released and has a release plan? The client can access the services right away. They use a 360-team approach. They are able to assist with emergency transportation needs, but do not provide TTC tokens to get from point A to B.

Dina, Tammy and Justice McInnes acknowledged the valuable service they are providing as well, how much they appreciate what they do. Tammy acknowledged that working in a hospital setting there are limits of using creative venues to support people dealing with mental health, addictions and the justice system.

- 2)How are these initiatives changing or shaping the HSJCC's role in our community? (Please consider the impact of the COVID-19)

- 3) What are the **top three issues** or challenges in human services and justice coordination in our community?
- 4) What are the top three priority areas that NY-HSJCC will be leading over the next year?
- 5) What support would the NY-HSJCC like to receive from the Provincial HSJCC to achieve our mandate?
- 6) What should the P-HSJCC start, stop or continue doing?

What new initiatives are occurring in our environment that are impacting the work of our HSJCC

• Geographical impact of the New Courthouse and New Bail Centre

The top three issues identified are:

- The gaps and services for older individuals with dementia who have no history with the justice system and can't return home.
- People with sexual offending charges have limited referral resources.
- People who are charged with arson can't access housing resources due to assessment.

The top three priorities are:

- To have a safe beds program for elders with dementia
- To address the impact of isolation on one's mental health
- To address the impact of PTSD

**Themes discussed:** Cota has a geriatric program. Tandy will gather more information about their referral process and provide it to Dina.
