# Approval of January 12 and March 2, 2023 minutes

The minutes of January 12, and March 2, 2023 were approved.

#### **Review Action Items:**

Action items were reviewed and completed.

Presentation: Matthew Carrol on the Toronto Community Crisis Services - North West

- What is the Toronto Community Crisis Service? Four sites: Downtown East, Gerstein Crisis Centre, Downtown West, 2-Spririted People of the 1<sup>st</sup> Nations, Northwest, Canadian Mental Health Association Toronto and Northeast, TAIBU Community Health Centre
- Context was provided. Develop a community, non-police led response to people experiencing crisis.
- Crisis response that reduces the harm that is disproportionately experienced by Black, Indigenous, Racialized, LGBTQ2S people and those struggling with mental health and addictions
- 24/7 service, voluntary, consent-based, 16 years +, trauma-informed care and harm reduction, "no wrong door approach, mobile crisis team, post crisis follow-up, case management and service navigation, culturally relevant services and referral network
- Can access the TCCS by calling 211 or 911. Will meet where the client is at, offer wrap around services
- Follow-up services offered within 48 hours
- NW pilot collaborative partners were discussed

- Crisis workers skillset: experience in community mental health, crisis intervention, experience working
  with issues related to substance use and concurrent disorders within a harm reduction approach,
  includes people with lived experience, youth, Indigenous identified, and nurses
- Serving 23, 12 and 31 Police Division
- The City of Toronto completed a six months report on the TCCS confirming the effective success of the mobile/crisis service
- Cultural services and referrals provided
- TCCS catchment map will be circulated
- CMHA Toronto has a new website

Matthew was thanked for the informative and insightful presentation.

#### **Lunch and Learns**

Tammy provided the report on the Anti-Racism series. 1099 registered for this series, and 453 attended the sessions. It was a very successful five-part series. 99% rated the content above average to excellent. Due to the success and feedback, the Toronto Anti-Racism Ad Hoc Group is addressing repeating the series.

#### **Member Annual Evaluation:**

# **Agency and Organization Updates**

- Bradley reported that the MNO justice program is expanding and continues to work at the federal level to meet justice and policing priorities. Hiring new positions update: manager, eight restorative justice coordinators, youth restorative justice coordinator, justice program specialist, and data evaluator. We are looking at becoming more involved at the courthouse.
- Victoria stated that it is unknown when people will be released, impacting the high volume of referrals and waiting for the two courthouses to emerge, so things are unsettling. Cota's staff is rotating and working on a new schedule to reflect the recent changes. Victoria will provide more updates at the next meeting.
- Tonya acknowledged that LAO is in a transitional state. Clients are asked to be brought in person at the Regional Bail Centre if they have to meet with the mental health office.
- Meeting members acknowledged many unknowns due to the Regional Bail and OCJT changes. Members agreed to provide updates at the next meeting.
