11) Community Justice Centres Update	 There was a sense that the 3 proposed sites would roll out eventually, but there have not been any recent updates otherwise.
	ACTION: Katie will ask Joan Barrett (MAG) whether the submitted proposal re: the Community Justice Centres is a publicly accessible document.
12) Information Sharing re: Police- Hospital Transition Protocols	 Rosa Taddeo (MCSCS) & Ruth Stoddart (MOHLTC) advised that the release of the Police Hospital Transition Framework is awaiting Ministerial approval. Prior to the release, Rosa requested members share with her any current, successful police-hospital transition protocols that can be cited in release materials. Need to confirm that these protocols are still up and running and are meeting performance indicators. Problem is that the 3 originally cited within the working group no longer exist. The NW just signed an updated protocol and can send this information to MCSCS. Bill Chantler to bring this back to the Justice Committee meeting to ask if there are any police hospital transition protocols that exist and have performance indicators. Unfortunately, we are in a catch all situation – police services will not adopt the protocols until government recommends and the government won't release until we have indicators that these protocols are being used and are working. ACTION: Niagara, Hamilton, Ottawa, Thunder Bay and Bill Chantler (OACP) will look into the request from MCSCS to determine if there are police hospital transition protocols being used in their areas and if they have performance
13) Discharge from Court Protocol Update	 Khatija Laloo MCSCS provided an update on the Discharge from Distant Court Program: The "Red Envelope" background, DDCP criteria and the internal process of the program were discussed. MCSCS is looking into to have tracking information so that they can use best practices to expand all of the institutions eventually Phase I - implementation in the Eastern region, central region, western region, northern region - these were chosen based on institutions who already had linkages in the community Phase 2 - implementation to expand to other institutions identified by MCSCS Phase 3 - expand to all institutions to hold clients on remand Updates - The Terms of Reference, Generic Communique & Q&As have all been developed and will be shared soon with HSJCCs for distribution.

It was suggested that MCSCS should consider how to incorporate client feedback in the evaluation of the program. If community organizations and stakeholders have an interest in being part of this program at their institutions, they can email Khatija with an expression of interest.
14) Aging Populations and the Justice System	 Tiffany, Michelle & Cathy gave a presentation on the Safe Pathways Project pilot re: seniors with dementia who interact with the justice system. Guelph-Wellington Response to this issue looked at both prevention & post-charge responses. Katie noted it would be extremely helpful if clients on probation had medical assessments done so that probation officers would be able to divert the individual away from unsuitable programming i.e. for seniors with dementia who are required to attend domestic violence intervention programs. The presenters noted that they haven't had much success in terms of finding housing for individuals who cannot return home to their caregiver after a charge. There is some limited funding for sending these individuals to retirement homes for a short-term response. Next Steps for this Project: Phase I: Develop a navigational guide which will be informed through stakeholders Phase II: Having this guide to allow a task group to have some things to work on. Part of their responsibilities would be to determine scope of this issue. ACTION: The Secretariat will send an email to the network re: The Aging Populations & the Justice System Project, giving an opportunity for those in the network to share their work related to this issue and advising them of a future webinar.
