

There were 13 voting members present, representing 12 of the 14 regions. Sara acted as Chair for today's meeting and welcomed members to the P-HSJCC biweekly virtual updates meeting of September, 2020.
Co-Chair Sara Dias acknowledged due to time constraints, there were some items that the Executive Committee was unable to address at our last meeting. The items included the following: • HSJCC's approach to Anti-Black Racism (raised by Fran Truong, Chair of Halton Regional HSJCC) • Release from Custody Network / CoP • Discussion re: P-HSJCC Terms of Reference Feedback from PWLE Advisory Committee Secretariat will be tabling these items for discussion at the next Executive Committee call in October and will prepare discussion at the October P-HSJCC meeting. Co-Chair asked all for approval of consent agenda using the 'Agree' function in Adobe. MOTION: Sharron B. motioned to approve the consent agenda, Trevor seconded. Co-Chair noted that the Executive Committee met via Zoom and really enjoyed connecting using this platform.
