This is something that requires provincial level support ➤ Part of the complex needs issue is the higher level of distress in many clients requiring more intensive support (more staff time) and in turn, more supports from staff (vicarious trauma issue) ➤ The Community Network of Specialized Care have Dual Diagnosis Justice Case Coordinators/Managers who could provide input on the needs of those with developmental disabilities and best practices ➤ Therapy is a very important tool, which benefits clients with complex needs ➤ Sara – There are many unattached individuals, so we need to ensure we are not too narrow in our asks ➤ Dianna – At the ministry level, P-HSJCC/organizations need to specify what is needed for additional funding – i.e., additional services, more specialized services, higher staffing ratios ➤ Sara – What are ways that we can gather data/information to support the needs identified from a provincial lens? <p>ACTION: Secretariat to incorporate feedback and update proposed priorities for approval at the March P-HSJCC meeting.</p>
