The committee gave presentation on the abilities and work of the HSJCC and it was reported to have gone well, and the committee expects to continue to have a good working relationship with this individual.	
Halton Regional HSJCC	 Halton Fetal Alcohol Syndrome (FASD) Leadership Group received grant approval from Trillium for \$143,300 over 36 months to support the work of committed parents, caregivers and service providers to increase awareness and reduce the stigma associated with FASD by hiring a part time project coordinator and providing program supports to create integrated education, assessment and prevention FASD strategies. Halton Community Treatment Court (CTC) is occurring every other Friday and the population is ever growing resulting in it now running into the afternoon. Anecdotal analysis found that 80% of participants exceed both their own and the Crowns expectations; 10% pass but do not gain from the program; 10% fall out of the program. Feedback from participants is that the program is "life changing", "the approach of the court has changed their life". Approximately 10-15% of participants have been youth. The program has seen its first FASD client. Clients going through CTC have found having access to the Crown and being able to have conversation and/or ask questions directly has played a huge role in their success and greatly improved the process. Halton Drug Treatment Court (DTC) has been running since April 1, 2013 with the first participant being in August of 2013. CMHA HRB has a new Manager of Mental Health and Addiction, Diane Versace who started January 12, 2014. Kimberly Cato, Team Lead of Case Management Services, is the new Chair of Halton Regional HSJCC. Rhoda Frank is stepping down as Co-Chair and the invitation for another agency to step into this role has been extended.

DT-HSJCC had a tour of the Toronto South Detention Centre (TSDC), an adult male detention centre with 1650 beds, including 26 beds for people with acute mental health needs. It will open at the end of January 2014. CAMH will deliver a Forensic Early Intervention Service (FEIS) at the TSDC. Inmates will be screened for mental health issues when they are admitted to custody and those who screen positive for serious mental health will be referred to FEIS. The Toronto West Detention will close in April 2014. NY-HSJCC had a very successful lunch and learn in November. The topic was Concurrent Disorders: Recovery Approaches to Complex Problems, presented by Wayne Skinner MSW, RSW, Deputy Director of the Addictions Program at the Centre for Addiction and Mental Health (CAMH), and Robin Cuff, manager of Drug Treatment Court Services at CAMH. Waterloo-Wellington Regional HSJCC Sharon Deally-Grzybowski	 The OPP Training Learn and Lunch 2 days workshops, sponsored by the Guelph HSJCC in December 2013 were a success. Presentations were on Drug Treatment Court, MH Court and Diversions, Mobile Crisis and Homewood's Emergency MH Unit. It was a good opportunity for the OPP Officers to meet the MH and Justice Services personnel and to interface with colleagues who were noting similar issues. A similar Learn and Lunch training is currently being planned for presentation to the Guelph Police Services in the spring. Sponsored by the WWHSJCC, Conestoga College students are working diligently on gathering information necessary to produce a report incorporating literature review, descriptive analysis, and process description of MH Courts with a focus on the Waterloo MH Court and the Guelph Court process of dealing with issues relating to MH. The Cambridge and Kitchener HSJCCs are initiating plans to do a half day free workshop on the topic of MH and the Elderly – contact with the justice system, to be presented sometime in February. At the January 29th webinar, Joslyn Gaston, Chair of the Kitchener HSJCC, will be presenting on the issue of "Prisoners' Belongings" as it pertains to the Kitchener-Waterloo Region.
