Welcome and Introductions:

- Everyone introduced themselves
- Three students from Ryerson were introduced and welcomed. They are doing their placement at TEDC, CMHA and Scarborough Rouge Hospital

Review and Approval of Minutes of January 11, 2017

- The minutes were approved.

Action Items Follow-up

- Samim Hasham reported on the identified gaps in services in Scarborough relating to complex clients. The health links are addressing this issue. It was recommend that we contact Priscilli Tory from the health links and invite her to do a presentation to the committee. Domenica Dileo will follow-up.
- Action items were completed

Presentation – Enoch Landau on the Service Resolution Project

Enoch Landau provided the background to the Service Resolution Project. The Toronto Regional HSJCC had a Complex Care sub-committee that was exploring gaps for addressing system barriers dealing with complex situations. Taylor Newberry Consulting was hired and produced a report which made model recommendations to hire a Service Resolution Coordinator. The Toronto Regional is providing support for a

one day coordinator as a one year pilot project. They are in the process of deciding on a host agency to second a part-time staff.

There are various service resolution tables, the main gaps is that there is no justice focus tables.

Reviewed the logic model for the Service Resolution Project

- There will be an oversight committee which will provide project guidance
- Coordinator Integration - develop role, tracking tools, evaluation and readiness
- Facilitation Connection – coordinate work with existing SR tables.
- Identification of justice gaps
- Develop recommendation
- Implementation of recommendations and determine the feasibility of recommendations

Lunch and Learns

- It was suggested that we ask committee members what topic they are interested in for future Lunch and Learns in the Fall. One topic suggested was a Health Links presentation. Domenica Dileo will survey the committee members to make suggestions about future Lunch and Learn topics.

Agency/Organization Updates

- Michele Graham reported that CHIRS and Fred Victor have a partnership for a substance abuse program starting March 7th.
- Vincent Lee reported that at the TEDC there is about 400 individual in the facility.
 - As a first step the Admitting and Discharge Nurse will provide information regarding fentanyl, addiction and overdose information to all individuals who are newly admitted to the institution. Individuals who self-identify will be provided with a Naloxone Kit and education surrounding its use before they leave the institution. Implementation is scheduled for Mid-Spring.
 - Introduced a body scanner to help staff detect narcotics and weapons
 - Completed two test for video fitness hearing: one with OTN and the other with Ontario Shores. The next step is to finalize a schedule for Fitness assessments with Ontario Shores.
 - An increasing staffing positions for mental health services. TEDC is hiring: a psychologist, social workers, mental health nurses, recreation officers and correctional officers. Hope to complete the hiring by the end of March
 - Looking at the Blood Test Act and implementation.
- Veronica Snooks is selected to join the public advisory committee to assist the City of Toronto's poverty reduction efforts. Congratulation to Veronica. More than 350 residents applied and 20 were selected to be part of the Lived

Experience Advisory Group (LEAG). Announcement link will be circulated with minutes.

Review/Approve 2017-2018 Workplan

It was agreed to request from the T-HSJCC \$1500 for TTC tokens and Food Vouchers. It was agreed to have two Lunch and Learns per year in conjunction with regular meetings.

The workplan for 2017-2018 was approved to be submitted to the T-HSJCC for approval with the following budget:

Lunch and Learns: \$540

Honorarium: \$600

TTC tokens: \$1000

Food Vouchers \$500

Total budget - \$2640 (\$500 increase from previous year)
