#### **Presentation:** Brian Smith on Focus Table

- Slide decks will be distributed to the members
- A collaborative risk-driven approach to community safety and well-being
- Acute Elevated Risk (AER) Situations is a reference to any situation impinging on individuals, families, groups or places where circumstances indicate an extremely high probability of the occurrence of harms or victimization.
- FOCUS Situation Tables at the Local Level brings together the most appropriate community agencies at a weekly situation table to provide a targeted, wrap around approach to the most vulnerable individuals, families and places that are experiencing heightened levels of risk in a specific geographic location.
- FOCUS Toronto supports local situation tables with coordination, administration and special tools that strengthen outcomes for vulnerable populations.

- FOCUS Toronto Steering Committee provides strategic oversight of the operations of the FOCUS Toronto
- How does it work? A multi-agency team meets once a week to identify individuals, groups and places that are at high risk. The first element of response happens between 0-48 hours following a meeting.
- Brian Smith was thanked for an informative and interactive presentation

#### 2018-2019 Workplan

Reviewed the 2018-2019 workplan, which was circulated prior to the meeting. Discussion ensued- to continue with the regular five meetings and two Lunch and Learns. Continue with the TTC and food voucher support for the courthouse. The goals and objectives remain the same as previous year.

It was agreed to add under section 3 Issues Identification of the workplan the following:

• Explore active engagement strategies

Domenica Dileo reported that the budget goal of the T-HSJC is to have a balanced budget. After reviewing the Locals budget requests, the committee had to limit the amount of TTC tokens and food vouchers for all Locals with the understanding that surplus can be used for TTC tokens and food vouchers purchases. The T-HSJCC will review outstanding Locals budget requests in the Fall.

The S-HSHCC committee unanimously approved the 2018-2019 workplan and budget. Proposed meeting dates are: September 12, November 7, January 9, March 6 and May 1st.

Domenica informed the committee that a member's survey and membership update as per funding requirement takes place annually during April. We have a core membership of 15-20. It was suggested that the survey ask members why they do not attend meetings. It was acknowledged that complex care is outstanding.

It was acknowledged that Toronto Housing, Homeless services, Scarborough Community Heath Centre are missing at the table.

# **Agency/Organization Updates**

- Dr. Samim Hasham informed the committee that there is a new program RAAM which stands for Rapid Access Addiction Medicine and its focus is withdrawal
  management from opiates and alcohol at the Scarborough Hospital. Samim is
  providing support for the various RAAM clinics opening soon. Anyone can access
  these clinics dealing with concurrent disorders.
- Sharon Williams informed the committee that the Scarborough Hospital will have a RAAC/RAAM clinic opening soon. Will update the committee as information is available and/or presentation.
- Susan Boucaud reported that the Toronto East Detention Centre has hired six Social Workers. All units are assigned a SW. Have full staff complement.
- Greg McInnes informed the committee about the Durham project Discharge
  From Distant Court Programs for vulnerable clients AKA The Red Envelope that
  the Salvation Army is involved. This program helps vulnerable people track their
  belongs. MCSCS is in partnership with internal and external partners. For
  example, Durham courthouse can get belongings for Lindsay without going
  there.
- Diana Filici reported on the Métis Nation of Ontario restorative justice project. Planning to provide service in April.
