Peer support staff accompany clients to court and share their experience, knowledge and insights. There are specific Crown Attorney's who work with Human Trafficking cases. Domenica Dileo reported on the January 9, 2019 Lunch and Learn on Domestic Sex Trafficking of Youth. Total participants: 36 including presenters and 20 (65%) completed the evaluation. Main concern identified was that it was too short.

# Approval of Workplan 2019-2020

Tazio Clarke reviewed each item of the Workplan 2019-2020 with the committee. Themes discussed: It was identified that police membership is missing at the table. Any assistance to invite the police to the table is welcomed. It was noted the importance to continuously looking at how resources and referrals take place among members and/or gaps in services. Committee members unanimously approved the workplan 2019/20.

It was suggested to look at the use of technology for Lunch and Learn webinar. Jennifer Altosar from Surrey Place offered usage of their Blue Jeans webinar technology. Domenica will follow up regarding the feasibility of using this service.

# **Updates from T-HSJCC and Provincial HSJCC**

T-HSJCC meeting took place on February 6, 2019. There was a presentation updating the committee on the New Toronto Courthouse. Construction is expected to be completed by spring 2022. The New Toronto Courthouse will be located at 10 Armoury St. It will accommodate the Toronto OCJ criminal courts program. This includes the Mental Health, Drug, Youth and Indigenous courts. The Toronto Regional approved the Scarborough HSJCC workplan 2019-20 and requested budget. The next T-HSJCC meeting is on May 8<sup>th</sup>, 2019. Provincial conference is taking place November 4-6<sup>th</sup>, 2019: Colouring Outside the Lines, more information to follow.
