# Welcome and Introductions:

- Everyone introduced themselves
- Three new staff from Toronto East Detention Centre were introduced and welcomed. They are: Melissa Lynch, Social Worker, Tazio Clarke, Social Worker Manager and Behzad Goudarzi, Psychologist.

# **Action Items Follow-up**

• Domenica Dileo reported that she contacted Priscilla Tang. Was informed that the East Toronto Health Link has restructured into the East Toronto Sub-Region. Current mandate is in system-level primary care resources planning for the Michael Garron Hospital. It was decided to invite her to present at the September meeting to find out more how they are addressing complex client's challenges.

**Presentation** – Patricia Pagnani, Toronto Bail Program.

- The bail program sees clients minimum once per week. If they don't follow-through there is enforcement. Given that some clients could not follow through due to illness.
- They started a pilot project in February 2017 adding 8 new positions who are assigned the most vulnerable clients that don't comply with traditional requirement. This includes two indigenous positions and one in Scarborough.
- Annually 1500 people report to the Bail Program.
- When they reach 200 vulnerable clients they will reach their maximum capacity for the new positions. The new Enhanced Workers will be accompanying clients to various appointments in the community. This may include: Psychiatry, GP/family doctor, walk in clinics, Hospitals/CAMH, counseling/therapy groups, Probation Offices, CAS, methadone clinics, ID clinics, ODSP/OW office and case coordination with other agencies as well as court.
- Reporting will be done in person in the community whenever possible and/or otherwise in the office.
- Czarina Garcia is the Bail Program Enhancement Worker in Scarborough.
- If the individual has surety they do not qualify for the Bail Program, they step in when an individual does not have surety.
- Will work together with case managers from other agencies.
- If individual is well connected with other services might not need support from the Enhance Program.

Themes discussed: Does the Enhance Worker help with housing issues if the person is in the shelter. The individual will need a stable address to work with the Bail Program. Hostel address is fine but it has to be approved by the Bail Program.

• Patricia Pagnani was thanked for her informative presentation.

### **Presentation:** Andrew Enniss – Hostel to Homes Program

CMHA Hostel to Homes Program is in the  $2^{nd}$  year. The program is funded by the City of Toronto to reduce clients use of the shelter system.

- The City selected 200 long- term clients of the shelter system to be supported by the program.
- The objective is to provide ongoing support, access to resources for one year.
- Agencies involved in the project are: CMHA, Native Men's Residence, Fred Victor, Sistering, Cota, and Agincourt Services Association.
- Each agency is assigned to address the various support that the clients needs.
- Only the City of Toronto is allowed to make referrals. It uses a Housing First strategy
- The program is evaluated by St. Michael's Hospital.
- The Streets to Homes Outreach worker provides one-on-one support to provide housing stabilization options.

Theme discussed: Who to contact at the City of Toronto for referral? Policy questions can be directed to Leslie Jardin at the City of Toronto. Please send any policy questions to Domenica Dileo who can direct them to Leslie Jardin and share her reply with the committee.

Andrew Enniss was thanked for his insightful and informative presentation.
