• Domenica Dileo completed the Lunch and Learn topic survey. Provincial conference information was circulated.

Presentation – Lauren Caruana, DPFP Implementation Coach CAMH on Staged Screening and Assessment and the Ontario Perception of Care tool.

- What is SS&A Implementation of a new staged screening and assessment process in all publicly- funded (Ministry of Health/Local Health Integration Network) addiction programs in Ontario.
- Mandated for the addiction sector.
- Stakeholder feedback in many forms along the way
- Early positive impacts

- Next Steps development of web- based learning for GAIN Q3 MI ONT assessment tool, ensure people have access to the new reports, tool changes based on feedback, analysis of system level data and shifting to full implementation
- OPOC-MHA standardized validated tool, empowers service users, working in all 14 LHINs, implementation coaches working with agencies to develop agency action plans. There are two versions of the tool. One with 32 questions and for nonregistered there are 17 questions. The tools do not address gambling and eating disorders.
- The tool has been translated into five languages.
- Themes discussed: Data can be shared and used for funding. Trainers to commit for two years term.
- Lauren Caruana was thanked for her insightful and interactive presentation.

Lunch and Learns

Domenica Dileo reported on the Lunch and Learn survey topic priorities result:

Based on the survey results the priority topics were Cannabis and Elderly/Dementia

The first Lunch and Learn will take place at the November meeting and second at the January meeting. The committee approved for April Trewhitt from CMHA will speak on Cannabis.

Agency/Organization Updates

- Tammy Alston informed the committee that the CMHA Mental Health and Justice Program is open for referrals. Referral form will be sent to Domenica Dileo to circulate to the members. Referral criteria: Involvement with justice or possible involvement with police living in Scarborough. See attached brochure and referral form
- Samim Hasham informed the committee that CMHA is developing an opioid tool kit which will be distributed in the next few months. Also, Public Health has funds available for Harm Reduction programs.

Service Coordination/Resolution Issues

- Samim Hasham informed the committee that there is a new Sub-region at the Central East LHIN, The committee expressed interested in inviting the Scarborough LIHNs to discuss their role and how we can better address complex care needs in Scarborough. Domenica Dileo to invite them to present at a future meeting.
 - Discussion ensued about the complex care needs in Scarborough. The following needs were identified:
- Individual with a sexual assault record can't get housing
- Individual with a history of arson can't get housing
- Long waitlist to get a psychiatrist

It was agreed that Domenica Dileo send an email and ask members to submit case studies about the needs and barriers faced by complex clients. This will help us have a conversation with the Scarborough Sub-LIHNS.
