Presentation – Lori Brady from the Central East LHIN

Discussion ensued regarding – Why were the Sub-regions established? What are Sub-region Planning Tables? They are seeking health system stakeholders – patients, caregivers, Indigenous representatives, Francophone representatives, and New Immigrant representatives to participate in Sub-region Planning Tables.

The LIHN's is taking the direction of the Planning Tables to work locally. The Central East LIHN is the most populated LIHN in the province. The Tables inform and advise but do not develop policies or direct funds.

Reviewed the Planning Tables Members for Scarborough North and South. Scarborough South Table has vacancy for Addiction membership.

Jai Mills is overseeing MH and Addiction,

Lori Brady is overseeing Scarborough South
Farrah Hirji is overseeing Scarborough North

It was suggested we contact Jai Mills for complex care issues dealing with mental health and addiction.

There was acknowledgement that the justice piece has not been identified in the sub-region planning tables. Lori Brady informed the committee that the Sub-regions continuously review issues. Hence, the justice dialogue is not closed and it was agreed that we continue with open communication as we move forward. She will take the discussion to the Sub-region table.

It was also acknowledged that chronic users of the system are not addressed by the Health LINKs. Suggestion was made to link the Health LINKs to the LIHN.
