Updates from T-HSJCC and Provincial HSJCC.

Domenica Dileo reported on the Service Resolution discussion at the Toronto Regional meeting of October 16, 2019. She provided the context of the Service Resolution process. Newberry consultants were hired and made recommendations,. There is a Complex Care Sub Committee that reports to the Toronto Regional HSJCC. Rhona Zitney was hired as the Service Resolution Justice Coordinator; she had a broad mandate consisting of one day per week. Her main role has been education and capacity building. In the past several years there has been changes in the system i.e Focus Tables. What is the best way to serve complex clients in the justice system? Can we identify what the gaps are? Role of the DT-HSJCC?
