7. 2023-2024 YTD Budget

a) The October Year to date budget was reviewed at the meeting. We are in a surplus of \$3,825.59 dollars. The budget will be attached to the minutes. If you have any needs that we can support to your clients, please let us know.

8. Champlain Regional HSJCC meeting update (Johanne Renaud / Marisa Moher)

Johanne R. and Marisa missed the last meeting. Their meetings are at the same time as ours, we'll try to change that. Johanne shared the Orientation online module for new committee members; it's done as a course. It outlines the provincial, regional and local membership committees, who we are, upcoming events, resources, reporting, workplans, documents, forms, regional projects. It gives an opportunity for new members to learn about us. It is also great for networking and sharing resources. We'd like to incorporate this in our strategic plan, to try to get additional members to join our committee, also for that engagement piece and use for training. It is very easy to follow, gives a lot of information. The link was sent to the members and it will be sent with the meeting minutes as well.

9. SDG-PR 2023-2024 Workplan and update from Chairs of the sub-committees

a) Direct Services

Create plans of care, service plans/release plans, provide counseling and referrals (All)

Johanne R. shared that they are about to do a review and resign the MH Pre-charge Diversion Protocols with the OPP from SDG, Russel and Hawkesbury as well as the Crown Attorneys for each area. Some members of the police services/Champions have changed. Once approved and signed, we will offer some training to the champions and include the Mobile Crisis teams. The one with Cornwall has been redone and signed recently.

ii) Liaise with Vibrant Communities of SDG (Carilyne Hébert)

- We have completed the Well-being Report Card for 2022-2023. It can be found at the following link along with the updated strategie: https://sdccornwall.ca/wp-content/uploads/2023/11/2022-2023-Well-being-Report-Card-and-Updated-Strategies-V2.pdf
- Our Wellness room Pilot in partnership with CMHA is going very well. The UCDSB will be the next school board to implement a space within one of their schools
- The Health Human Resources Project Team that we co-lead with the GROHT has been meeting monthly and will be working on strategies to address the shortage of medical professionals in the region.
- We continue to manage the Building Safer Communities Fund that was awarded to the City of Cornwall. In August 2023 we provided 11 community agencies with a total of \$100,000.00 in funding for youth programs. We hope to make this fund available in 2024.

- Working Groups have been meeting to identify some priorities for early 2024. We
 intend to survey all service providers (health, justice, social services etc.) to identify
 the accessibility to services. This information will be used in the spring to ideally
 address major gaps in accessible services. We will also be working with partners in
 hopes to establish an emergency funds to support families in individuals who are
 experiences unique crises.

iii) Prescott-Russell Wellbeing and Safety Advisory Committee (Michel Chretien, Administrative Coordinator)

Michel C. was absent at today's meeting, however, Johanne R noted that the working groups are looking at transportation, MH and Addiction and Housing.

iv) Client Care Kits / Supportive needs (Joanne Ledoux-Moshonas)
 HSJCC will continue to support agencies with client care kits. Requests are to be forwarded to Joanne L. M. by way of email with the amount requesting.

b) Hoarding Response Coalition PR (Johanne Renaud)

i) No updates since the last meeting. We would like to get Animal Welfare to present at a future meeting. We are looking at doing a campaign for the 10 Steps for a Safer, healthier and more comfortable Home poster is available for distribution. Looking at the option of delivering with the Add bags. Because of the cost, Johanne suggested we do different areas yearly until we reach them all. Joanne LM agrees with this recommendation and asked to receive the estimate as the HSJCC might support the cost.

ii) Hoarding Response Coalition of SDG (Jason Pollick)

No additional information to report. This year, our funding was reduced so we have had to adapt and improve, with diminished resources. Our new leads have started a Buried in Treasure program. It's being very well received. Team leads are interested in doing information sessions in our area to various community partners to educate the public and to possibly get some additional funding. We would like to get some more community partners on board. There is a lack of quality affordable housing in our area, so one challenge we are facing is finding housing for hoarding clients who have been evicted or whose homes have been condemned.

c) Situation Table Advisory Committees

- i) SDG&A Situation Table (Elyse Lauzon-Alguire)
 - As of January 1, 2023, we had 27 cases of Acutely Elevated Risk come to the table. We are basically on par since we started in 2017.
 - Agencies are welcome to bring forward case consultations (there are not formal referrals of Acutely Elevated Risk) – the case consultations are helpful if an agency is looking for guidance/suggestions on a particular case.
 - Doing virtual information sessions every 2 months, 2 hours by Zoom, it's a new opportunity to learn about the Table, how to make a referral, a review of case studies, mock scenario recording, etc.

ii) PR Situation Table Initiative (Michel Chretien)

Johanne R. shared that the meetings are every two weeks, we don't have many cases presented, the Steering Committee is going to meet in January.

d) Training and professional development (Co-Chairs)

i) HSJCC Virtual Provincial Conference – November 15-16, 2023

The HSJCC paid for (6) registrations for members to participate in the conference **Striving for Inclusive Justice: Reflecting on the past and acting for the future** was held **November 15 and 16, 2023** conference. Feedback was very positive and felt that the caliber of speakers was good.
