Presentation - Janice Sellon, East Metro Youth Services

- Provides Children Mental Health Service
- 40 years in Scarborough catchment area, serving youth from 12 to 18 years old
- Non-mandated service
- Provides a variety of services: residential (3 group homes); counselling and case management; developmental services; newcomer program for young people new to Canada; youth engagement program
- School-based programs include program for youth with Asperger Syndrome;
 youth employment program
- Provides housing, and MI and addictions services

- Expanding focus on Aboriginal, Tamil, Afghan, LGBT and Roma communities
- what's up walk-in is a free MI and Addiction counseling service for youth and families (pamphlet was distributed)
- Able to send youth attendance record to probation
- Case management has access to psychiatrist and psychologist

Agency/Organization Updates

- Erwin Black reported that Cota's branding has changed "Cota" is now a word not an acronym. The new concept is 'Cota' Inspiring Change'. Cota will present at the March 2014 S-HSJCC meeting.
- Carole Sinclair reported that the deadline for SASP 2014-2015 applications for new grants is December 9, 2013. Domenica Dileo will forward the application to the S-HSJCC members. Seed funds of up to \$30,000 are available.
- Susan Boucaud reported that Justice and Mental Health had a presentation on posttraumatic disorder. The presentation was held in the Engagement Centre of the TEDC and the JAMH staff (Carolyn Nonkes and Jawad Bhatti) allowed the presentation to be available electronically. The presentation was well received by the TEDC staff who attended.
- Neil Longley reported that the Toronto East Detention Centre population has increased because of the Toronto South Detention Centre transitions.
- David Raponi-Monk reported that the new John Howard building should be ready by the end of November. The housing office at 740 Broadview will not be moved to the new John Howard location
- Flo Skinner will send Domenica Dileo information for distribution on the Centenary merge when it's definite.

Iustice Collaborative

- Umwali Sollange reported that the JC has identified the main transitional point it will focus on, (1) when people are arrested and (2) when they are released. There is a working group that will tease out the issues further related to release planning.
- The next meeting will be on November 20th. The focus will be on narrowing down the area of focus. They will look at the evidence research, or mapping resources of what is available, and what can JC add.
- By December, they hope to have a plan.
- The issue of medication in discharge planning was identified as a gap

- The discussion of people with lived experience was deferred to the next meeting agenda item.
- Neil Longley reported on Recommendation 5 of the Review of the Scarborough Mapping Project which states: The SHS&JCC should advocate for the return of a Special Needs Unit to the Toronto East Detention Centre. The Toronto East Detention Centre is waiting for directions from the Toronto South Detention Centre. The TSDC will have a new medical unit that will provide case management.
- Domenica Dileo reported that welcome packages were sent to Second Base Youth Shelter, Scarborough Homes First Shelter for Adults, Beth Eisenberg and Surrey Place. Carole Sinclair linked Domenica Dileo to the Shelters, and initial contact has been made with OW.

T-HSJCC and P-HSJCC Update

- David Raponi-Monk provided a report on the T-HSJCC
