#### Welcome and Introductions:

Everyone introduced themselves. Barry Sharp was welcomed to the committee.

# How is COVID-19 affecting service delivery in your organization, sector and/or community?

- Jason noted that Crown Attorney's Office has moved from using the telephone to
  using video to communicate with people in conflict with the law. If one does not
  attend video court the ramifications are that a bench warrant may be issued and
  clients have to virtually attend court to have the bench warrant rescinded. The court
  set date system can not stop.
- Joy informed the committee that Centennial winter semester is starting January 18<sup>th</sup>. They run academic upgrading as well as literacy programs at the Toronto East Detention Centre. Currently their programs are online. They are able to provide technological devices if the student does not have access to them.
- Barry informed the committee that he is replacing Becky Paonessa. He is active in all the courthouses providing spiritual support and runs a positive lifestyle program which helps clients with day-to-day life.
- Sherubi noted that she was a former student of Sharon Williams and is working at CAMH in the nursing resource unit and as a psychiatric nurse at Toronto South Detention Centre (TSDC).
- Michael informed the committee that he works at the City of Toronto with youth in conflict with the law. He noted that technology is not accessible to his clients. The

lockdown is affecting client's employment or lack of and he is trying to encourage clients to stay positive. There are limited paid programs taking place virtually and he is continuing to work with other agencies to provide support to their clients.

- Tazio noted that he is trying to navigate the virtual landscape and he is going in person and/or virtually when there is court.
- Samim provides clinical consultation at the Rapid Access Addiction Medicine Clinics and teaches at Mc Master University and the Faculty at Adler College.

- Building Up is a non-profit social enterprise and a pre-apprenticeship program.
- Mission: To train, employ and prepare Torontonians faced with barriers to employment for successful long term careers in the trades.
- They work with people who are in conflict with the law.

# Eligibility:

- 18 years+
- Available Mon-Fri: 7am to 4pm
- Legally able to work in Canada
- ESL/LINC Level 6 +
- Flexible with working in all types of work conditions
- Willingness to commute to various sites
- Capable of lifting 50 lbs +

It is a 16 weeks program often paid \$14/hr

Support is individualized: They recognize that different people need different types of support

Everyone will have a Case Manager that will guide them throughout the preapprenticeship program. Most participants live in TCH.

- Continuity of Support Long Term: participants must be actively prepared to move on from Building Up and into a career in the trades. On-going, in-house counselling support provided

- Suggest to change the workplan objectives to reflect racialized community challenges and enhance anti-racism education and engagement.
