Review and Approval of Minutes of January 6, 2021

Minutes were approved by Jason and second by Erwin.

How is COVID-19 affecting service delivery in your organization, sector and/or community?

Jason noted that people are encouraged to attend court via video. If a bench warrant has been issued the police have a procedure in place to follow.

Erwin reported that they have been using telephone and ZOOM to engage with clients in the community to address their needs.

Dana noted that she has a new role at E Fry as community outreach supervisor in Scarborough and Toronto. No direct catchment area. Working with Black, Indigenous and

people of colour. The Exit Doors Here offers services to women who are: street-based sex workers, women who may be trafficked, and private/non-identifying sex workers (indoor sex work, massage parlor workers, dancers, etc). The program supports people where they are at. Using PPE and distributing hygiene products to women in need. Referrals can be made internally or by external sources. They provide counselling and are in partnership with PASAN.

Tazio noted that staff at the Victim Witness Program are increasing person- to -person trials and continue to offer the same services.

Themes: Discussion ensued about the importance of having people with lived experience share their insight and expertise on this committee.

Legal Aid Barriers and Challenges

Presentation: Barry Sharp from the Salvation Army

- Salvation Army is a church first and then a social service provider.
- Historical context was provided of the organization
- It was noted that the thrift stores provide volunteer opportunities
- They provide women, men and senior shelters thorughout Toronto as well as recovery programs and addiction services
- Broadview Village provides support to adults with developmental disabilities and mental health challenges
- The positive lifestyle program runs for 14 weeks currently using ZOOM or Microsoft Teams or over the phone allowing engagement with participants. They provide counselling, not thearapy or a psychiatrist

- Community Justice Programs are offered which target problem areas leading to criminal involvement and these include: anger management one day, anger management intensive, anger management (women only), anger and relationships (men only), theft intervention, alcohol and drug awareness, positive parenting, and road rage.
