# Review of January 11, 2023 minutes

The minutes of the January 11th meeting were approved by Robert Koslowski, and seconded by Valeria Danieli.

**Presentation:** Justice and Mental Health Program at the Scarborough Health Network with Tasha Castagnier-Seery, Manager; Dr. Andrew Wang, Psychiatrist; Halimo Hashi, Social Worker; Sara Adams, Social Worker; Olufunke Babalola, Case Manager

- -The Scarborough Health Network Justice and Mental Health Program (JAMH) offers services to client's living with the challenges of chronic and persistent mental illness, (Schizophrenia, Bipolar disorder, and Psychotic disorders) who have some active involvement in the judicial system.
- -The program mandate is to reduce recidivism and hospitalizations through tailored interventions based on evidence-based practice.

Use a multidisciplinary team approach.

Referral process from probation offices, detention centers, psychiatric hospitals outpatient mental health clinic, family doctors, and in the community

## Client Profile Example - Pathway

The client referred to JAMH through his probation officer

The client met with the probation office through social workers to help the client understand the program and its services.

Consents for treatments and collateral signed.

The client was scheduled for a 60min assessment with the psychiatrist and assigned social worker. The client can choose to be accompanied by any social support.

Note- JAMH does not have a waitlist, clients are usually scheduled within a couple of weeks of referral.

Social work provides client-centered case management and counselling.

This process is developed collaboratively with the client. Support can happen in the office or the community.

JAMH staff work with relevant stakeholders (courts, housing, probation, family) to meet the mandate of reducing/eliminating rehospitalization and recidivism.

<u>Themes discussed:</u> The MH and Justice program aims to serve by postal code, but it isn't always possible (precarious housing, etc). If they are connected to other services in Scarborough, they can support them as well.

No waitlist, an individual can see the psychiatrist within a few weeks. Do you provide emergency services? Monday-Friday the program operates from 8-4 pm, If one needs to be admitted to the emergency, there can be a WRAP process which Dr. Andrew can facilitate. Able to refer to the Scarborough Mobile Team.

Tasha and her team were thanked for a very informative, engaging, and insightful presentation.

#### **Lunch and Learns**

The Anti-Racism series session 4 of 5 took place on February 23, 2023, addressing the professional perspective with Shawna Kelly and Dr. Welsley Crichlow. It was successful.

## **Approval Workplan for 2023-2024**

The workplan 2023-24 was circulated before the meeting. Domenica reported on the workplan budget:

- -TTC tokens \$600
- Food Vouchers \$650
- -Lunch N' Learns/Anti-Racism Series \$1250 (Hybrid Model)
- -Honorarium \$450
- -Police Division TTC tokens for Bail Releases \$335 (NEW)

Domenica reported that pre-covid individuals were released from custody, but are now released from the police stations. Patricia Pagnani, Bail Manager had a meeting with the justice sector partners regarding the individuals who are released from the police stations who have no access to TTC tokens. They acknowledged that vulnerable individuals can benefit from receiving TTC tokens to go from point A to B when released from the police stations. The Toronto HSJCC was approached for help with TTC tokens for vulnerable individuals released on bail from the police stations. A new budget line has been created to address this emerging need for vulnerable individuals.

Committee members unanimously approved the workplan and budget for the 2023-24 fiscal year. Final approval will take place at the Toronto Regional HSJCC meeting.

## **Agency/Organization updates**

Tammy stated that the West Courthouse is now the Toronto Regional Bail Centre, and the court diversion program at the Scarborough Courthouse is preparing to move to the New Toronto Courthouse. CMHA staff is providing full-service face-to-face.

Graham reported that 2 CMHA staff are providing service at the West Courthouse/Bail Centre.

It was acknowledged that the courthouses are continuing with the virtual process. Robert stated that he contacted Agincourt Community Services to find out if they can present regarding the services they provide. No reply as of yet.

Nirmala informed the committee that Jolly Thompson, Don Mills Area Manager passed away suddenly.
