# Review of September 13, 2023 minutes

The September 13, 2023, minutes were approved by Melissa and seconded by Robert. Please note that the November 2, 2023 Mega Meeting with all four Locals replaced the regular S-HSJCC November meeting.

**Presentation:** Valeria Danieli on the P-HSJCC Anti-Racism Committee Work PowerPoint slides will be circulated to HSJCC members

- A Working Group was established in **January 2023** to support development of an **Anti-Racism Framework** for the Provincial HSICC Network
- To ensure anti-racism is a priority item for Local, Regional and Provincial HSJCCs.
- To provide provincial guidance and a consistent approach to addressing anti-racism across the human services and justice systems.
- To provide concrete ways the HSJCC Network can participate in dismantling of structural and systemic racism.
- In spring of 2023 a call went out to community connectors.
- Seven focus groups took place.

- Concerns were raised regarding data usage and privacy and noted.
- Across all focus groups we were able to extract rich data from the conversations that will directly impact the development of an anti-racism framework for implementation across all HSJCCs.
- Valerie was thanked for the informative and insightful presentation.

#### **Action Items:**

- -Based on the members meeting length and time poll results; the meeting will start at 1:00 and end at 2:30 p.m., and the length is back to pre- COVID of one hour and a half.
- -Discussion ensued on the Local HSJCCs Mega Meeting on November 2, 2023 summary report.

**Themes discussed:** The mega meeting indicated the overwhelming interest of members in coming together and engaging to build relationships. Members acknowledged the importance of face-to-face contact, which allows them to network, build relationships and address common problems by coming together and working collaboratively.

The advantage of hybrid meetings is that they allow more members to attend them. Action items were reviewed and completed.

The three main areas for the working groups to address separately are 1) Release, Transportation and Belongings; 2) Accessibility, Inclusion and Diversity; and 3) Communication.
